Your statement for additional care settings

From the first day I arrived at the care home, I was constantly involved in fights. I was the youngest person there by around three years, which made me particularly vulnerable. Some of the older residents tried to force themselves on me, and at such a young age I was exposed to drugs, alcohol and cigarettes. The females names were Natalie and Gaynor.

Staff would restrain me simply for speaking out or opening my mouth. At the time, I was only around 4 feet 8 inches tall and was much smaller than many of the people around me.

I was also denied access to my mum and was unable to call her for approximately four to six weeks. I was not properly informed about how close I actually was to her. My mum's old house was only around a mile away, yet I was made to feel much more isolated from her.

I stayed at the care home for approximately four months. The home wanted to keep me there for longer, but my mum refused to allow me to return. I had originally been placed there because of behavioural problems, but instead of receiving the support and care I needed, I felt neglected and mistreated.

At one point, I was left in a storage cupboard because they said they did not have any proper space for me. I felt that staff did not make an effort with me because I was the youngest. If I was punished or got into trouble, the police would sometimes be involved rather than staff dealing with the situation appropriately. There were also occasions when staff drove us at around 70 mph on roads with a 40 mph speed limit. We were young children and were frightened, but it felt as though our fear and safety were not taken seriously.

The environment also exposed children to behaviour that should never have been normalised in a care setting. Cigarettes were given to children, and drinking alcohol appeared to be tolerated as long as staff did not directly see it happening. Being exposed to alcohol, cigarettes and drugs at such a young age had a significant impact on me.

I was a vulnerable child who needed care, protection and guidance. Instead, during my time there, I experienced violence, fear, isolation, inappropriate restraint, exposure to substances and situations that no child should have had to deal with.
