Q1 | What is the name or location of the relevant care setting you were abused in?

Q4 | On the next page, please provide as much information as you can about:

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

You can continue on additional pages if you need to.

Your statement for additional care settings

I was first placed into care when I was nine years old after being removed from my mum's care. I remember going into school one day with a black eye. The school carried out a full-body examination and found evidence of physical abuse on different areas of my body. I went to school that morning and never returned home. Instead, I was placed into foster care.
