- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was then placed in this children's home. By the time I arrived, I was already struggling badly with alcohol and would describe myself as an alcoholic, despite still being a child. No one seemed to recognise how serious this was or tried to get me the help and support I clearly needed.

I told them that I did not want to be placed in foster care, but I felt that nobody listened to me or took my wishes seriously. I actually wanted to be placed in a secure unit because, at that time, I did not feel safe. I was a vulnerable child who was clearly struggling, but instead of listening to me and understanding why I felt this way, my concerns were ignored.

After I was placed in the children's home, my stepfather left my mum. Despite everything he had done to me, he continued to visit me regularly at the home. He would give me money, which I believe was intended to keep me quiet about the abuse I had experienced. This meant that even after I had been removed from home, I was still being exposed to the person who had abused and manipulated me.
