Your statement for additional care settings

My foster parents were an older couple in which we called my foster mum Gran. She was very dominating. She would threaten us and beat us with a wooden spoon, she beat me that hard that I remember going to school the next day and I was unable to sit down without being in discomfort or pain due to the beating from her.

I was fostered alongside my siblings and throughout the years, my foster mum would make it clear to me and my sister that she had wished to have a boy. This really messed with me mentally and made me feel as if I become a problem just because we was placed there.

For my foster parents to adopt my brother, they had to take me and my sister in with them too which they done in order to get there boy but weren't happy deep down about having 2 girls alongside it.

We was also told whenever social services came over to visit us that we are not to tell them anything that was happening otherwise we'd get a punishment.

Looking back, I question why we was never allowed to be alone with the social worker to tell our honest opinion but we never was as she was always there with us or in the same room.

We took physical beatings, humiliate us and play mind games with myself and myself to try and turn us on each other, cut our hair short enough that she didn't allow us to have long hair and this was done at home by her. I was neglected of birthday parties and never allowed friends over or anything. I even had to wear boy shoe's to school which knocked my confidence and self-esteem at a very young age.
