I was abused in my family home from a very young age. Because of this, I was removed from my family and first placed at Flemington House, Uddingston. My gran worked there at the time but she was off sick. I was kept at Flemington House while my gran was off sick. I was only meant to be there for a few weeks. During this time, I felt safe there and believed I would be okay. I even went on holiday with them, and for the first time I felt happy and relieved to be away from my home situation.

At 13 years of age, I was taken away under the Section 21 Act. I was then placed in Wooden Dean Children's Home, Blantyre, where I stayed for around one year. This period was the worst time of my life. From the moment I arrived at Wooden Dean, I knew I was not safe. My elder brother had previously been placed there, and I already knew what to expect. The mental and sexual abuse began here. The environment was chaotic and frightening. The children were left to run wild, with no proper supervision. They were violent, feral, and unpredictable. I was regularly punched, picked on, called names, and beaten up, and I was constantly forced into fights. Although this was terrifying, it was something I felt I had to cope with because there was no protection or support. Most of the time, I was left completely on my own, unless the other children were stealing my clothes and belongings. There was clear neglect — we were expected to fend for ourselves, with no care or guidance. Punishments were extreme and inappropriate. My pocket money was taken, and I was locked in my room for long periods of time, isolated and distressed. Staff allowed and encouraged me to drink alcohol, and I became an alcoholic from a very young age. There was no help, no intervention, and no support. I was told I was destined for jail if I didn't stop drinking, but alcohol was the only way I knew how to block out the trauma and abuse I was experiencing. While in Wooden Dean, I became pregnant at the age of 15 by another child in the home. The adults knew what was happening and did nothing to stop it. I was groomed and sexually assaulted. Staff deliberately moved me from a single room to a room right next door to the boy who assaulted me, which was mentally and emotionally damaging. I had no understanding of right and wrong, no protection, and no guidance. I was a child and completely vulnerable. The food situation was also neglectful. When I first arrived, meals were cooked, but after that we were left to cook for ourselves. We had very little food, extremely small portions, and it was often inedible. It was either eat what was there or go hungry, which happened frequently. I witnessed staff behaving inappropriately towards other children. I was always aware and alert because I had experienced abuse from a young age. I recognised when adults or boys were being inappropriate. I tried to stand up for myself, but when I did, I was punished and secluded, rather than protected.

I was then taken to Strathern, where I was supposed to be assessed to return home. I wasn't even there for one night. When I arrived, I asked for food because I hadn't eaten all day. I was told no and ordered to go to bed hungry. I reacted because I was starving and in pain. Instead of helping me, they sent me straight back.

Your statement for Care setting 4 continued

I was then placed back into Wooden Dean until around 15 years of age. At this point, I was pregnant, drinking heavily, and completely unsupported. I felt my life was already ruined. I thought I had finally escaped Wooden Dean, but I was taken right back. I was terrified. I told them I had lost the baby and said I had a termination because I was desperate for help and didn't understand what was happening. I was young, scared, and confused. I was not allowed to go back to my family, and when I had to pretend I had a miscarriage, I only managed to go to my mum's for a few days. Throughout my time in care, I was constantly bullied and targeted by both staff and children. I lived in constant fear for my life. I witnessed staff sleeping with young girls in the unit. One male staff member in particular didn't like me because he knew I wouldn't stay quiet. I called him beastly and creepy. Staff allowed the boy who got me pregnant to bring other girls into the unit deliberately to provoke and hurt me. They also encouraged me to speak on the phone to a 19-year-old man in prison, which was completely inappropriate. I had no privacy at all — staff would kick the bathroom door open while I was in the bath, leaving me humiliated and violated. As a result of everything I experienced — the neglect, mental abuse, physical abuse, and sexual abuse, both at home and more severely while in care — I have suffered devastating long-term effects. I now live with severe anxiety and PTSD, experience nightmares, and carry deep trauma. I do not trust anyone. I have been diagnosed with bipolar disorder and schizophrenia. I am deeply frustrated and distressed by how I was treated as a child, and the damage caused has followed me throughout my life.
