- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

My time here in Glenochil was an absolute nightmare. 2 officers would come in to my cell at 5-6pm and would rape me, they would make me do oral sex on them too.

Over the 6-8 week period I was there, this happened for me between 15-25 times.

The same 2 officers also used to physically abuse me by hitting and slapping me over the head and threatened me with the trenches.

When leaving this place, the same officers come to me when I was leaving and said "if you tell anybody about what's happened I know where to find you".
