Your statement for additional care settings

I was taken out of my gran's care because they said I was out of control. Looking back, I don't believe that was the right decision. I suffered far more abuse in that care placement than I ever did living with my gran. If I had been allowed to stay with her, I truly believe I would have been fine. Instead of getting the support I needed, I was placed somewhere that caused me even more harm.

Whilst I was at the school, I was sexually abused by the maths teacher, Mr Bell. He abused me in the kitchen and also attempted to abuse me in the classroom. He took me into the kitchen and forced me to have sex with him when I was only 13 years old. I remember feeling frightened, powerless, and completely unable to stop what was happening.

I was also physically abused by other members of staff. They would restrain me, and the force they used caused me pain. Instead of protecting me and making me feel safe, the staff were the people who caused me the most fear and harm.

I went through more abuse in the 4 weeks I was here than I would've had my whole life in my grans care. They were predators, horrible, horrible people.
