Q1 | What is the name or location of the relevant care setting you were abused in?

- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was around 8 years old when being placed here and I was also placed here with my 7 year old sister.

This setting was quite brutal to experience at a young age. I suffered physical and emotional abuse. I was put in to care due to my mother becoming homeless.

I remember suffering beatings from the cane, and this for wetting the bed. When being getting the cane, I was taken to an assembly looking hall surrounded by nuns and priests. My name would be called out in front of all the children and we were openly humiliated for wetting the bed. The kids who'd wet the bed were put to one side and punished for this. My bed wetting problem started whilst I was in care but my sister's problem started before we was placed in care.

As another form of punishment for bed wetting, I'd be neglected that morning after wetting my bed by not being given my breakfast. This really did mess me up mentally.

The nuns here would also come in to our room at night and put their hands in our beds to check if they were wet. If you had wet the bed they would drag you out and make you stand their shivering whilst they changed the bed and this is when we were punished the following morning.
