We refer to your request for personal data.

Despite an extensive search of council systems and archives, we have been unable to find any of your client's historical childhood social work records.

Please can you confirm any other names used by your client. Was he ever placed in a care establishment other than foster parents? Was your client adopted? If so, it is likely Stirling Council may have these files.

At the time of local government reorganisation in 1975, it was agreed that the new Central Regional Council would be based in Stirling. Therefore, it is possible that your client's records may have been retained by Stirling Council.
