- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When i was placed here I was 13/14 years of age.

I remember being bullied by a big kid who used to tease me with my temper and he always assaulted me. At one point he sat on me and I couldn't breathe. He made me pass out and I was unconscious. This happened around 6 times to me on different. He used to slap me when I was down on the floor. One time he did slap me that hard that my mouth was bleeding.

I ran away from this care settings a few times as I didn't like my time here at all.
