- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

This was a very difficult and distressing foster placement. There were six children living in the household: two foster children, including me, and four of the foster carers' own children. I felt that there were too many children in the home and that my needs were not properly met.

If I did not finish a meal, the remaining food would be placed back in the fridge and given to me again the following day. I would not be given fresh food until I had eaten it. I repeatedly tried to tell my social worker about what was happening, but I felt that my concerns were ignored.

I was required to share a bedroom with the other foster child, who was a boy. This made me feel very uncomfortable. He was often unkind towards me and would regularly hit me.

One of the foster carers' biological sons was a teenager. He also frequently hit me and would deliberately kick balls at me. I understood that he resented the fact that his mother was fostering children.

I was forced to attend Weight Watchers because I was told that I was too big. I found this extremely humiliating. I made it clear that I did not want to attend, but I was given no choice. I was also told that if I did not follow their rules, I would be moved to another care placement.

I was forced to refer to the foster carers as "Aunt" and "Uncle".

I felt that they constantly criticised and monitored me. The only respite I had was when I went to the chapel next door. I mainly went there to get away from the household and to have some peace and time alone.
