Your statement for Care setting 1 continued

During my time at Rannochmoor, things were generally okay on the surface for the year I was there, but there were several experiences that have stayed with me. The environment was very regimented. Every morning we had to line up, and everything felt strict and controlled. Even though some parts of the routine seemed normal at first, the way discipline was handled made me feel constantly on edge. If I was considered “naughty,” they would slap me around the head. It wasn’t just discipline — it felt humiliating and frightening, especially as a child.

One of the worst things was what happened when two kids were squabbling. Instead of resolving it properly, the staff would take us upstairs to the attic where there was a boxing ring. They would make us fight each other, and we weren’t allowed to stop until we had really badly beaten each other up. This wasn’t done for our benefit — it was for the staff’s entertainment. They would stand there laughing and watching, and it made me feel deeply uncomfortable and unsafe. It was like our pain was something amusing to them.

They would also restrain us, but it wasn’t just restraint. They would physically beat me up while doing it. I remember feeling powerless, like there was no adult there who actually wanted to protect me. The people who were supposed to care for us were the ones causing harm, and that has had a lasting emotional impact on me.

Rannochmoor had its own school, but it was mixed ages, and the environment didn’t feel supportive. What hurt me the most was when they moved my sister to a different school. They separated us as a family, and that was incredibly upsetting for me. She was one of the only people I felt close to, and being split apart made me feel even more isolated. That separation has stayed with me and affected me long after leaving.

Looking back, even though some parts of Rannochmoor seemed structured or routine, the emotional and physical experiences I went through there have had a lasting effect on me. It shaped how I felt about safety, trust, and the way adults treated me during my childhood.

During my time at Anne Street, things were awful. I genuinely hated being there. Although we sometimes went away to the caravan at Easter, which on the surface seemed like a nice break, even those trips had their own problems. At the caravan pub, the children were allowed inside, but the staff would get drunk. When they were drunk, they became abusive. They would grab us by the hair and throw me around, and as a child I felt completely powerless and frightened.

I remember one particular incident involving a female member of staff. She took me out for a drive, and her husband was an RAF pilot. They took me out to the army base, and during that time she made strange and unsettling remarks about how my family wouldn't be able to look after me. She made comments suggesting they would take me away, and it made me feel extremely uncomfortable and unsafe. I didn't understand why she was saying those things, but I knew it didn't feel right.

This same woman later had sexual intercourse with one of the young kids in the home. Knowing this made me feel deeply uncomfortable and even more unsafe around her. It added to the fear and confusion I already felt, and it made me question who I could trust.

They would restrain me, but it wasn't proper restraint — they would physically beat me up while doing it. They would slap me, hit me, and use restraint as an excuse to hurt me. The staff would scream at me, call me names, and bully me. It wasn't just physical abuse; it was emotional abuse as well. I felt targeted, belittled, and constantly on edge.

Looking back, Anne Street was one of the most distressing places I stayed. The combination of physical violence, emotional intimidation, inappropriate behaviour from staff, and the constant fear I lived in has had a lasting impact on me. Even now, the memories of how I was treated there still affect me, and it remains one of the most difficult periods of my childhood.

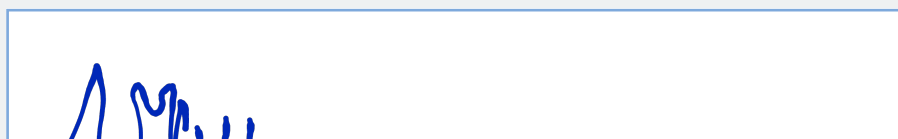

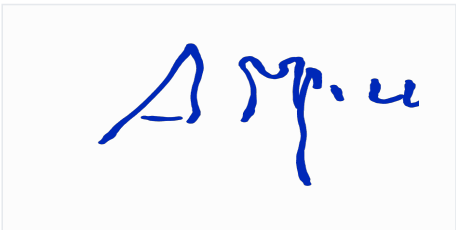
