- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed in this Foster Care I was around 5/6 years old.

I suffered Physical and Emotional abuse alongside neglect.

My foster parents would stop our contact with my birth parents if we misbehaving. I witnessed my brother be dragged across the house, from the kitchen to another room which he was then put in and locked in from the outside of the room.

When we told the social worker about this room and the locker, our foster parents called us a lair and said that this room didn't exists/have a lock on.

I would also watch the foster family eat the food they freshly got that day whilst not giving us any. We would get different foods compared to them.

Me and my sister would always be scared to be bathed in this house as our foster parents were intimidating. Unless social workers brought us clothes, we had to wear whatever they had. The clothes provided would were worn down compared to the other kids who were dressed nicely.

I remember one time my sister asked for some form of uniform for school in which she was shouted at to be grateful for.
