When spoken to by Neil G. and warned that he would have to make up the time later his response was 'does this look like the face of concern?' Jim also warning Kevin back - refusal to work & walked out of class. Also reports that Kevin was seen on education roof. Kevin spoken to at 4 PM by Mark R., Neil G. & myself about general lack of co-operation today. He was adamant that he was getting in his taxi. Various reasons given for problems today - those above plus saying he'd been up since 4 AM, was having difficulty settling into routine of school etc. Advised to talk to staff if he is having difficulties & possibility of timetable changes to make curriculum more accessible for him. Close supervision of attitude in education for the rest of the week. Agreed with him that as groupwork could not take place tonight until the 3 playing football returned that we would not expect him to stay the full evening. Instead, after dinner he would work with Chris & myself looking at the groupwork programme, rules for the group & what is involved, & we would arrange taxi for 6 PM. He

co-operated with this + attitude improved as time went on. Reminded to ensure that he leaves Tuesday evenings free for the group.

Pl to Alice - she reported Kevin missing on Saturday. He returned home 2:00hrs Sunday "stowed out of his net" he claimed to have stayed with [redacted]. Alice was saying that Paddy was last enough of Kevin's behaviour. Pl to PSW to inform him of above. 1-15-2-30pm individual session with Kevin. The main focus on Kevin's life is his friends closely following by drink and drugs (hash). His family come third. He does not understand that it is not acceptable for him to use his house as a hotel and to constantly spend the weekend drinking or smoking hash. I asked him what would be an acceptable time for him to return home each night. He seriously suggested 5am so he could get a couple of hours sleep before coming to school. He stated that he hated being in a house he would rather walk the streets.

Kevin initially helped another yp to calm down, which he did effectively. He was involved in playing pool with the entire group. During Dinner Kevin chose to sit at a table isolated from the group. During the quiz again Kevin's conduct

could be described as being at the margins of the group. He completed the questions after the prize was changed to little fruits. At the end of the quiz Kevin filled in the evaluation form indicating that he won't be back. When asked why he indicated he would like to be outdoors. Given that the next group is going to be an activity it was felt that an outdoors activity may be appropriate. As the group moved into the pool area Kevin went into TV room and jumped out window, a member of staff went onto campus, as soon as Kevin saw staff member he walked back towards nurses unit without prompt. On return Kevin relaxed playing pool until his taxi arrived.

23/10 Spoke with Alice McGowan - Kevin has had a good week no issues. In bed this morning. Informed about school start time & group.

24/10 Plc to mum to find out why Kevin has not attended school today - Apparently he refused to get up this morning. He was out with Dad last night and went to bed at 11⁰⁰-11³⁰. He was not smoking hash, so that is not why she couldn't get him up. I said I would phone tomorrow at 8.30 and asked Alice to let him know I'd called. Also informed her that I'd be taking over the care & would arrange to come down and see her.

25/10 Plc to mum - Kevin on his way.

Arrived on time and attended first two classes. We then had keytime - discussed his difficulties in getting in to school and how he feels about this. He appeared to be quite honest in his replies - doesn't like school, doesn't want to do any work and when he wakes up, he doesn't see the point in coming to school. I advised him that he has 3 months to remedy this problem or he may become a residential pupil. He does not want this. I told him that if necessary I would come down and get him up in the morning - but he needs to take some responsibility. And Kevin also discussed his care offerings and

30/10 R.T.S ON TIME - BOTH MUM + HE SAY W/C LEAVE WENT WELL. KEVIN SMOKING ON CAMPUS AND ALSO LEFT SCHOOL GROUNDS, WITHOUT PERMISSION, TO BUY CIGARETTES AT THE GARAGE. R.T.S AFTER 10 MINS. OUT OF CLASS FOR CIGARETTE IN AFTERNOON. NO OTHER ISSUES. TAXI HOME AT 4.⁰⁰ PM. I DID A HLW TO INTRODUCE MYSELF AND GET SOME BACKGROUND INFO. I WILL ARRANGE TO DO A PROPER ASSESSMENT A.S.A.P.

14/11	Kevin arrived in school at 0915hrs & was taken to see W. Cosh. W. explained the difficult situation quite clearly to Kevin and gave him the opportunity to say how he felt and how he would manage his anger and aggression in the future. Kevin did not have any effective response or answers to give to Willie and when he was offered the opportunity the^{to} resolve the situation with Kevin he replied "I'm not bothered". Willie asked him if that was a yes or a no & he just repeated the same response. Kevin showed little or no commitment to his placement or changing his aggressive behaviour and it was a senior management decision taken by G. Bell that Kevin could no longer be accommodated at Kibble for his education. Kevin took the news with no real change of emotion, very relaxed & laid back throughout the whole process. He had stated earlier that he didn't want to go back residential & he wanted to stay at Kibble. He also stated that he didn't care about things and after the event of being told he was out of Kibble Education that at least he wouldn't have to get up for school in the morning. Contacted S.W. & informed of decision. Could not manage to contact either parent. Left a message for the Senior Educational Psychologist - Elizabeth Harle - and given that we could not take Kevin home as there was no one available John took him off-campus for the day. Continued to try & contact Mum all day but to no avail. John was taking Kevin home for 3.45pm as we expected Mum to be at home for the younger children returning from school, however Kevin took John to the wrong address and then got out of the car & left (52 Staffa St. Gourock). S.W. was informed of all the days events at 4.10pm when he returned to his office. The Snr. Ed. Psych. had also spoken to G. Bell & was satisfied with the outcome and happy to await formal written correspondence from W. Cosh. Managed to contact Mum at 5.35pm to inform her of all of the above. Mum took the news calmly but continues to be utterly confused at Kevin's behaviour and lack of interest and commitment. She gave some information on events of the weekend also. He was returned home by a family friend on Thursday night and Mum, unable to wait for S.W., asked him about the

incident with [REDACTED] when he allegedly told him he had been "raped as a wee boy". Kevin denied he said anything like that even though Mum was reassuring & supportive of him. On Friday he saw his S.W. who also discussed this issue with him but again he denied ever saying anything like that.

Kevin went out again on Friday and when Mum went out to see if she could pick him up at the back of eleven at night, Kevin was annoyed because he thought it was far too early. He got into the car but jumped out again nearer home. When he did get home he collected the dog and walked to Gourzok where he tried to get into his "Uncle Tams" house & a friend's house unsuccessfully. He then walked back home & dropped the dog off before walking back to Gourzok where he stole a car. It is unclear as to whether he was picked up by police, sleeping or sitting in the car but the clutch cable had apparently broken and Kevin was taken to the police station. Mum refused to collect him & suggested S.W. standby do so but they also refused & the police insisted that it was their responsibility & eventually they collected Kevin from the police.

He stayed in Bed most of Saturday but went out again Sat. night. Mum picked him up at 9pm but he left again & returned at 12.45 am.

Sunday he phoned & Mum picked him up at 9pm & Monday he was in for 10.15pm. His brother has been talking a lot about drugs - ecstasy & blues and that Kevin is going to end up on heroin. Mum stated that she always checks him out & she hasn't noticed anything.

Assured her that although Kevin is excluded from Education, we will continue to offer him support & working on his anger management. Suggested that Aleksair will call her tomorrow to update and arrange to see her & Kevin.
