09/01/2008	Mckenzie Gill	Meeting with Billy today. Billy seemed in really good spirits and was cheery and chatty. Discussed how he feels about moving in with dad, and he said he is really happy to be there. However, he had said that he is arguing with his brother already. I advised Billy that his money would now be put up, and asked if he could bring his bank details next time we meet as it could be paid directly into his bank. Advised Billy that he would have to pay his dad board money of at least £15-£20 a week. I explained to Billy that his dad has to pay rent, buy food pay bills etc., and that he should now be contributing to this. Billy said he would offer his dad board. Also discussed Billy attending careers again. Explained that now he has left care he is entitled to an incentive payment weekly if he attends training as well as his training allowance. Advised Billy that I would support him to attend careers interview with Ceri again, but he said he would rather get a job. Asked Billy to think about this and we will discuss it at our next meeting. Have arranged to meet weekly for 4 weeks. Advised Billy that he has any problems or would like a chat at any time to just phone.
08/01/2008	Mckenzie Gill	T/C to Richie at Strathcarron. Richie had spoken to dad and Billy has officially moved in. Richie received a phone call from Street Level requiring Billy's keys as soon as possible. Advised Richie that Billy had given a months notice and that we pay for that month, therefore, although it would be ideal if Billy removed his stuff soon, there is no immediate rush as far as I am concerned. Informed Richie I would speak to my line manager regarding this.
07/01/2008	Mckenzie Gill	After calling Street Level I was advised that Billy would need to write a letter confirming that he is handing in his notice. This was done and I handed this in. Asked about electricity and was told that this would be cancelled so he does not accumulate any bills.
07/01/2008	Mckenzie Gill	Meeting at Strathcarron. Billy has advised that he definitely does not want to move to Street level. Staff and Billy informed me that he plans to move to dad's. Staff have spoken to dad and were advised that this was fine and he has bought a new bed for Billy. Staff at Strathcarron are to call dad and make arrangements to move Billy on. Asked Billy to look out for his TV license which will be sent to his flat, so it could be cancelled. Informed Billy that he could keep the TV and it would come off his section 29 money. 18/12/2007	Mckenzie Gill	Took Billy for his starter pack. Also got Billy his TV and ordered a TV license starting from today. Spoke to Billy about whether he thought he was ready to move on. I informed him that he could change his mind, and put Street Level on hold. Billy was adamant that he is ready, but does not want to move before Christmas. I went over what will be expected of him, eg house management, budgeting, cooking etc. I advised Billy that he would get help with all these areas and he is pleased about that. Had a very good day with Billy. He was very chatty and quite excited about moving into Street Level.
17/12/2007	Mckenzie Gill	Took Billy to sign for his tenancy. Have arranged to meet with Billy to get some items for his flat tomorrow.
12/12/2007	Mckenzie Gill	Informed Billy that he has been offered accomodation. He is quite excited about this. Discussed with Billy that he does not need to take this and can put his application on hold until he is more ready. Billy said he is ready and is keen to move. Also discussed that he should to a phased move to new tenancy, but he is not keen to do this, think it is just bravado though. Billy viewed flat and likes it. Discussed with billy in the car the positives and negatives of his own accomodation and he just said he knows all this. Went shopping to get him his messages for Strathcarron. Went in to tell staff Billy likes flat and plans to sign for it on Monday.

We discussed how Billy would feel about this, and we both thought that he will be anxious about moving on. Billy did not want to do cooking when we got back to the unit. Billy also refused to do his pathways and said that he would not be doing it again because it was boring. However, Billy has done half of it, and I will gather more information during our meetings. Billy had said today that he does not want to leave the unit, and will miss it. I informed Billy that nobody is forcing him to leave, and he would move on gradually. However, Billy will probably change his mind about this next week.

Told Billy that I enjoyed our session and that I would see him next week.
