Mrs. Hunter has been away from the house now for well over a year during which time Mr. Hunter has been coping on his own.

The home is a 4-apartment house rented from Greenock Corporation and is in the Gibbstown area of the town, an area where there is a high degree of delinquency. The home is not very well maintained and is frequently dirty and untidy, but it must be remembered that Mr. Hunter is the father and mother to the children, and five children on their own are a handful for one parent to cope with.

Mr. Hunter looks after the children as well as he can, he seems to be genuinely interested in them and usually is a very good father when he is sober. However, often at weekends he drinks home brew with one or two of his drinking associates and this is usually when the trouble starts. The children themselves never know what to expect of when anything is going to happen in the home so that

has very much taken over the mother's role in the house, and the children depend a lot on her. [redacted] is a carefree sort of lass who would talk to anybody and who has a vivid imagination. However, [redacted] I feel is the sensible lass who keeps an eye on the younger children. Mr. Hunter is in for a divorce, but at the moment very little has been heard of this. He is also an epileptic, and I believe has had other illnesses. He occasionally has epileptic turns but of course these are unpublicized as to where and when they can take place. However, Mr. Hunter is a good financial manager and has never any problems with rent, gas, electricity etc. and has always money that he can borrow from him. However, he shows little affection for the children in many respects and he seems to have

the idea that if they are fed, bathed at some time, that they are being well looked after. I believe he needs to show more affection for the children and be more reliable in his conduct. A home help was placed in the house about three months ago but latterly with the pressures building up in the house, the home help left it. During the time she had been there, the house was a lot cleaner and Mr. Hunter himself seemed to be making an effort to be pulling himself up again. However, the home help left the next day the children were removed, and Mr. Hunter is pretty depressed about the whole idea. His attitude towards other people is that they have no right to know his business and in many respects I think this is what he looks on many of his social workers, other local government officers etc as interfering busybodies. He is quite content to keep his business to himself and in general copes quite well with it. However, he often has friends up in the house when they have a good drink between them. This is usually when the trouble starts and as I stated and as I stated, it is totally unpredictable when this will happen. The children I feel are living in a very unstable environment, not knowing where or when something might happen, when the father is going to come in drunk or when he will get annoyed and take a swing at them. He often could be classed as being aggressive when you ask him how he is coping or you pick him up on anything on the house, fallen back on his alibi that he is the only parent in the house and that he is doing pretty well and that he wants to keep the children with him. However, once you gain his confidence he is quite a likable fellow but he prefers people in many respects to do things for him rather than he has to do them himself. He is quite prepared to let the children be treated for their heads, report to his clinic, especially if someone else will take them, but is not too keen on them going if he has to take them. He does have the interest of his children at heart but I feel that it is a lot for him to cope with.

Conclusion

The children are living in a very unstable environment and I do not really think this should continue at the moment. Mr Hunter is finding it hard to cope with them and being one father looking after five children on your own especially when your health is not all that great is a pretty big handful. [redacted] plays a very important part in the house but it is an awful lot to expect a girl of [redacted] to act as mum to her brother and three sisters. She is very interested in the family but it puts a tremendous burden on her shoulders for her to have to do this. Taking all aspects of this case into consideration, I would recommend that the children be removed from this environment and placed in the care of the local authority in the hope that we can stabilise the home environment and also bring the children back up to scratch.

CONTINUAL DEVELOPMENT AND GENERAL PROGRESS:

December 1972. Brian is settling down very well and working away at school. He craves for affection. He has difficulty with his speech. He has been recommended for Speech Therapy.

January 1973. Brian is making good progress. Father visits regularly. Brian is very devoted to his Father. This child has outbursts of temper occasionally. He can be rough with the smaller children in the Group.

March 1973. Progress still improving. is now learning Highland Dancing. He is taking a keen interest in it. He sings quite nicely.

April 1973. Had a visit from his Social Worker. She thought Brian had greatly improved. He is mixing better with the other boys in the Group. His Dancing is improving. Father visits regularly.

May 1973. Brian is making steady progress in school. His speech is improving. He is expressing himself better. Mother visited. Brian was not too sure of her.

June 1973. Still progressing favourably, his School Report was good.

July 1973. Progress good. Brian is upset with the news that mother has gone again. He has become a bit quarrelsome again. He feels he has been rejected and keeps asking why has Mummy gone again? He hopes his Daddy will not go also.

August 1973. Father visited and took Brian and his sisters out for a few hours. He is upset that the home is not going to be made up again for the family. The children had a very enjoyable holiday at Saltcoats. Brian enjoyed the boats and building castles. He always built a little house, and called it his house in Greenock.

September 1973. Brian is now back at school and progressing favourably. Brian misses his Father's visits at the weekend. He has not been since before they went on holidays.

OCTOBER 1973 Brian is a very temperamental little boy is inclined to quarrel a lot with his little friends and if does not get his own way he has recourse to kicking and biting. He has been recommended to the Speech Clinic for therapy.

NOVEMBER 1973. Progress slow. is lacking in concentration as a result his Reading and number work is not improving. His Speech is improving.

DECEMBER 1973. Brian gets very unsettled at times this is usually after his Father visits. I know he misses the companionship of Father as he is the only boy in a family of four girls. He still gets temper tantrums occasionally.

JANUARY 1974. Brian is improving in school. He tries hard. He is still attending Speech Therapy at the Clinic.

FEBRUARY 1974. Progressing favourably. He attends Tutorial Classes which seem to help. Is doing very well at his dancing and is very upset if he has to miss his classes for any reason. He is getting on better in the Group, much more agreeable.

MARCH 1974. Progressing favourably. Speech improving, he speaks quite well when he takes his time. Has become a bit quarrelsome again. Is inclined to be jealous of others having something that he cannot get. He often fights until he has got what he wants. Even if it belongs to someone else.

APRIL 1974. Progress favourable, trying hard at school.

MAY 1974. Brian is working hard at school and does his homework each evening. Is also trying hard at his dancing and hopes to do an examination in Tap Dancing in a few Weeks time. Behaviour better. More pleasant.

JUNE 1974. School Report Fair. Teacher seems to think Brian is rather unsettled and this effects his school work. This may be because father's visits are not so frequent. He misses his Father. There are tears when he leaves.

JULY 1974. Brian did very well at his Dancing Exam. He was awarded a Certificate for Tap Dancing. He was very pleased about this. He is looking well after his fortnight at Saltcoats. He really enjoyed his holiday.

SEPTEMBER 1974. Brian has settled in well at school and is working much better with his new Teacher. He still attends Speech Therapy.

December 1974 School Report satisfactory. Brian is inclined to want a lot of his own way lately and can be rough with the other children if he does not get it. Father visited to bring Brian a Christmas gift. He is always more settled after father's visits.

March 1975. Brian's Speech has improved very much. His progress in School is general, and he seems to be more interested.

MAY 1975. Brian has obtained a Certificate in 'Tap' Dancing at the Barton School of Dancing. He is trying very hard at his Highland Dancing and hopes to do his Exam in it before the end of the Year.

AUGUST 1975. Brian is progressing favourably in his new class at St. Columba's School. He has been promoted to Primary V a3. He is still inclined to quarrel a lot with the other children in the Group. Uses his feet when he has a Temper Tantrum. Father's visits are more regular. This may help his behaviour.

OCTOBER 1975. Brian is becoming a more pleasant little boy and beginning to realise that he just cannot have everything his way. His work in School is very much improved in every aspect. Very interested in his Dancing.



December 1975. Brians Speech has improved , making progress all round.

February 1976 Brian is progressing favourably and more agreeable in the Group. He is fond of Animals and looks after the Budgie . This makes him happy and contented. Is always pleased to see his Father. He has joined the Cubs and is working hard for his Badges.

April 1976. Brian has been in bed for a few days with 'Flu, he has now recovered and back at school. He is making good progress at school.

June 1976. Brian has progressed very well this year and his school Report shows this. He is trying very hard to pass his Cub Scout Test. Father visited and Brian was very happy to see him as he had not been down for a few weeks. Brian fell and fractured his arm.

July 1976. Brian and the rest of the Group went on a holiday to Saltcoats for a fortnight and a week to Girvan. He enjoyed the Boating and fishing. The heated Swimming Pool was another attraction for him. He has now got the Plaster removed from his arm. Father has taken him home for a few days.

August 1976. Children returned to school on 19th August. Brian is now in Pr . VI . Brian is easily influenced by people about him . He is lacking in confidence in his own ability. He is really a disturbed boy who needs a lot of affection.

OCTOBER 1976. Not a great deal of progress in school due to lack of concentration. Can be very aggressive at times and rough with the little ones. Is interested in the Cub Scouts. Likes playing Football.

December 1976. Brian is pleased that his Father has permission to have him home for the Christmas holidays. He was also glad to come back to Nazareth House after the holiday.

February 1977. Brian is much better behaved since being at home . He is trying harder at school and is not so disagreeable in the 'Group'. Is now in the Scouts and is enjoying it. Is trying to help in the home. Father visits regularly. No contact with Mother who is living in England.

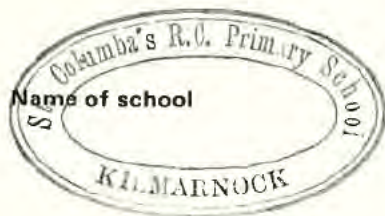

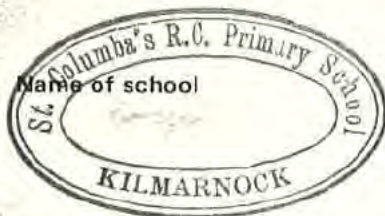
