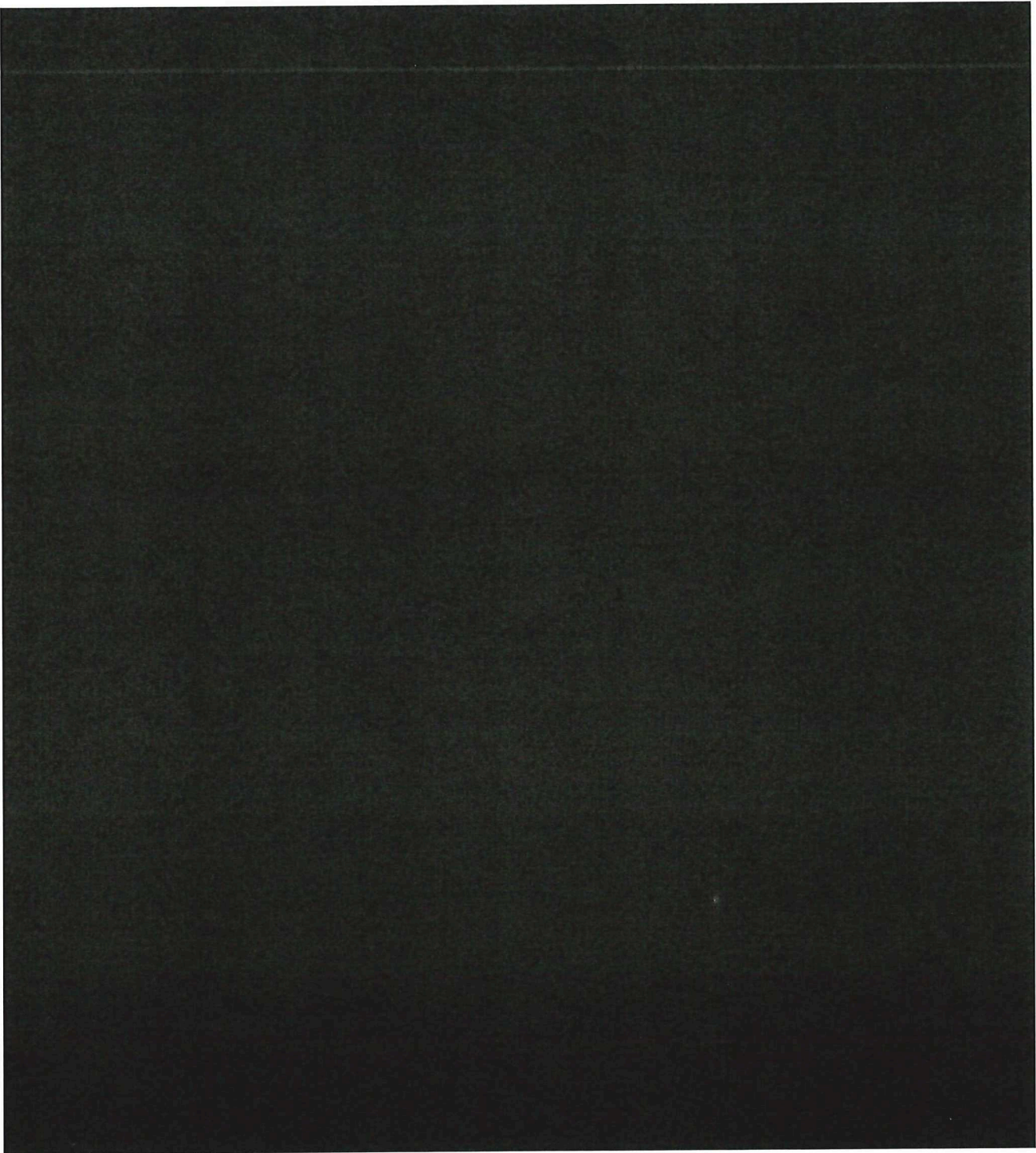

Throughout today Georgina has had several calls with her mother, with both Georgina and her mother initiating these. During one of the calls later on, staff attempted to use the phone thinking that Georgina had finished her call and heard a male voice saying "Say something bad to me", with Georgina replying "Lick my c—t". When challenged on this Georgina said that it was her brother she was talking to and that this was just a "saying". Staff advised Georgina that this was inappropriate, though she did not think so. When staff asked Georgina also admitted to staff that an acquaintance of her mums, [REDACTED] was also in the house at the time of the call.

When staff asked Georgina if the person on the other end of the phone was [REDACTED] she said no, maintaining that it was her brother.

I received a phone call on Friday the 16th Nov from [REDACTED] to inform us that she was thinking about moving away to England and to ask Georgie if she wanted the rest of her belonging brought to the unit. Margaret also informed me that she was shocked to hear that Georgie had told staff that she had a Miscarriage. [REDACTED] also said that she knew nothing about this until you had informed her of this. When I told [REDACTED] that we through Georgina had told her mum Margaret then went on to say that Georgina had a very heavy Period Which had lasted 3 days. I thank [REDACTED] for this information and said that I would go and speak to Georgie and get back to [REDACTED]. On speaking to Georgina she then changed her version of events and said it was her brother's girlfriend who had said that it could have been a Miscarriage. I then asked Georgie why she had said it was her Mum Georgie began to change her mind again and said it was a heavy Period. I then asked Georgie if this had been her first break in her pill since she had come home from her Holiday with the unit. (Georgie had been taken her pill for 2 Months as staff had phoned the nurse and asked if this would be ok to do as she would have had her break when on holiday with the unit the nurse had informed staff that when Georgie did come off her pill again it her Period would be more heavier than normal) Georgie then told me this was what it was like when I asked Georgie why she had told staff that she had a Miscarriage she said she didn't know. When I was on the phone to [REDACTED] I also happened to say that I would check when Georgie had last

taken her Pill [REDACTED] was not aware that Georgie was on the Pill. I apologies to [REDACTED] about this [REDACTED] then said that she through Georgie had the rods put in her arm as Georgie had told her this.

[REDACTED] also asked about coming down to see Georgie I said that she would need to contact yourself re contact with Georgie. Margaret also discussed Allegations that Georgie had made in the past I told [REDACTED] that I could not discuss these with her. [REDACTED] then went on to say that every time Georgie absconds from the unit that when Georgie returns she is Making wild allegations I again informed [REDACTED] that she would need to contact yourself re this. [REDACTED] said that she had spoken to you re this. [REDACTED] is going to phone you on Monday re her contact with Georgie

When starting shift on the above date [REDACTED]
[REDACTED] [senior], passed over that Georgie had requested to speak to the police the previous night, although there had been no feed back given.

Georgie asked if she could speak to myself later on the shift. I took Georgie to the office to ensure her confidentiality was being respected. Georgie informed me that she had informed the officers that while she had absconded and taken a female from the community with her to Gordon White's and mums house in Paisley.

Georgie told me that [REDACTED] made her change into shorts, he then started rubbing her legs in a sexualized manor and kissing her in a passionate way. I asked Georgie where her mum, gran and brother were at this time. Georgie informed me that her mum was there and was encouraging her to let him carry on. Georgie stated that she started to shrug him off and refusing to let him touch her.

Georgie then went onto say, when he could not bully her into letting him touch her he threw cans of lager at her which hit her just above her eye.

Gordon White then turned his attention to the other female whom Georgie had taken with her. Georgie stated that he made her get into short, then started rubbing her leg in a sexualized manor and kissing her passionately. [REDACTED] went onto tell this female that he was falling in love with her and wanted her to stay with him forever in his house. I asked Georgie if that was all that had happened. Georgie stated ''I told the police I think something else happened''. Georgie then asked if she could telephone this other girl as the police had asked her too. Georgie stated ''this other female is to scared to tell anyone what had happened''.

I advised Georgie I would speak to both her social worker and the police re this allegation and then get back to her with the decision.

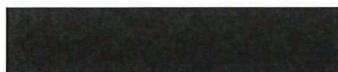

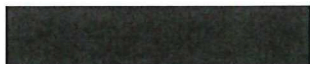

REPORT OF DISCLOSURE AT THE POLICE STATION THURSDAY 19.07.07

GEORGINA McMILLAN DOB - 04.12.91

Georgina had an appointment with the police doctor in Saltcoats at 8pm Thurs 19th July 2007 to disclose information of recent allegations made to staff in Harley Place Children's Unit. Georgina was asked questions regarding recent incidents while on the run with mum in Calendar, Georgina told the police doctor that at the age of 7 & 8 she was sexually abused by several different males. At the age of 11 a gang rape had taken place, a rape took place while being accommodated within a north Ayrshire children's unit by a male resident and while on the run with mum & mum's fiancé [REDACTED] Georgina disclosed that [REDACTED] had raped her while they were residing in Calendar approximately one month ago.

After all disclosures were made to the police doctor Georgina was given an examination of the vaginal area, the doctor could tell that sexual activity had taken place but could not tell when and how many times. The doctor felt that the vaginal area appeared to be healthy but advised that an appointment with the STD clinic is made in order for Georgina to be tested for any infections.

I have telephoned the clinic in Ardrossan & at this time I am awaiting on them calling back with an appointment time.

DISCLOSURE MADE TO R.C.W. - [REDACTED] ON
SATURDAY 21ST JULY 2007

On Saturday 21st July 2007 at approximately 5.40 p.m. Georgina approached myself and asked if she could speak to me privately. I then proceeded to take Georgina into her bedroom to allow her to have some privacy. Georgina then burst out crying and disclosed that she has been under a lot of stress recently with an alleged rape by her mother's fiancé namely, [REDACTED]

I interrupted Georgina by going through with her, our procedure of "confidentiality". Georgina was prepared to continue with her disclosure. Georgina stated that [REDACTED] not only raped her in Callender but in Blackpool and at her Mother's residence. This allegation apparently happened three months ago. Georgina was also complaining of stomach pain and said she had a thick vaginal charge. I asked her when she last had a "period" but Georgina could not tell me. However, she did say her period was regular but had not had one for a while.

Having discussed this disclosure with my Senior Shift Manager, [REDACTED] It was decided in the interest of the young person's health that she should immediately be taken to Crosshouse Hospital.

Georgina was given a pregnancy test, which confirmed that she was NOT pregnant. The duty doctor also examined her stomach area. Georgina declined on having a vaginal smear test. Georgina did agree to have an HIV and Hep C injection. Results will take approximately 6 to 8 weeks. The doctor on duty stated quite clearly to Georgina of what this procedure was for. Georgina was also given paracetamol for headache. (see medical log).

On our journey back from hospital, Georgina disclosed that different men have sexually abused her since the age of 6 years until approx. 11 years.

INCIDENT REPORT FOR GEORGINA MCMILLAN D.O.B 04/12/91 D.O.A 28/11/07

DATE INCIDENT REPORTED 08/05/07

On Monday 07/05/07 Georgina had entered the office within Harley Place Children's Unit and was having a conversation with writer. Writer was asking Georgina about her absconsion and why she hadn't attempted to contact with the unit. Georgina claiming that the night that she was supposed to return to the unit for her ov (18/05/07), her mum had put pressure on her to leave Johnston. Writer asked what kind of pressure and Georgina replied that her mum "hits her". Writer then asked if that's why she had got her friend to telephone the police. Georgina replied that it was she herself who had gone into the police station to report herself as she wanted to return to the unit as [REDACTED] had held a knife to her throat the previous night. Georgina then continued to say that she feels uncomfortable around [REDACTED] as he also hits her and bites her on the chest. Writer asked Georgina to confirm what she meant by chest and she replied that it was the breast, she then said that he also tries to kiss her. Writer asked if her mum was present when this happens and Georgina said that she is and she just sits there. At this point Georgina sat on a chair and said that her mum doesn't want her to live in Harley Place incase she talks about things that happened in the family and to Georgina years ago. Writer asked what she meant by that and Georgina continued to say that she wants to tell me but at the same time she doesn't. Writer explained to Georgina that she told me would remain confidential, although writer would be required to pass information to the senior Assistant Manager, Unit Manager and Georgina's Social Worker, who would in turn inform external managers and Senior Social Workers. Georgina then began to say that she had felt the same way in her dad's company as she does when she's in [REDACTED] company. Writer then asked her why she felt that way and Georgina replied that "I feel forced himself on her". Writer asked when and where this happened. Georgina replied that it began when she was about 7 years old and ended when she was about 11 years old, this took place in her dad's home whenever Georgina and her brother had an overnight visit. At this point Georgina became visibly distressed and was saying that she couldn't say anything before because she didn't want her mum to "demise" her. Writer then asked if Georgina had told anybody and Georgina replied that she had told her gran who had confirmed that Georgina's mum would "demise" her. Writer then spoke at length with Georgina regarding her feelings and emotions and she was saying that when "it first started" she didn't know what was going on, just that it was "sore and it nippy". She continued to say that as she got older she understood what was going on but that her dad had told her if she said anything "he wouldn't believe her" and "she wouldn't see her mum". Georgina also saying that she was scared that her uncle would shoot her dad because he is a hitman. Georgina continued to say that she felt guilty at not telling anyone and carries feelings of guilt. She said that she would like to tell her mum but is afraid of the consequences. Writer then asked Georgina what she would like to do about the allegations she has made. Georgina replied that she doesn't know. Writer explained that if she chose to have the police involved and make it an official complaint, staff at Harley Place would support her. Writer further explained that if she chose not to make an official complaint then she could still talk to writer and any of the previously mentioned members of staff who would be made aware of the situation at a point that she felt she needed to. Writer also asked Georgina to think about what she wanted to do carefully and to question her own capabilities at whether she could cope with the questioning and investigation of her disclosure and the consequences this may have on her family.

Georgina's mum visited the unit on the 17th May this contact was supervised by unit staff after mum had left the unit Georgina asked if she could go and visit her Brother who lives in the local area. Staff agreed to this Georgina was asked to contact unit when she arrived at her Brothers house Georgina did not contact the unit as requested. Staff tried to contact Georgina by phoning her brother her informed staff that Georgina was not with him and he had not seen Georgina. Staff then phoned Georgina's Mother who told staff that she would try and get in touch with Georgina and get her to contact the unit. Staff did not hear from Georgina and when they tried to contact Gergina's mother her Mobile Phone was turned off. Georgina was the reported as an Absconded and Social Work Standby was informed to date (04/06/07) staff has had no contact from Georgina and her fax to the Police is still live.

DISCLOSURE FROM ABOVE NAMED YOUNG PERSON – MONDAY 23RD
JULY 07

The writer and Georgina had the opportunity to have one to one time out in the community. This was beneficial for Georgina and the writer to build on a positive relationship as well as giving Georgina a chance to talk about recent events that allegedly took place in Callendar.

During our conversation, Georgina opened up to the writer and disclosed additional information about her alleged rapes by her mother's boyfriend, namely [REDACTED]

Georgina disclosed that different males have sexually abused her since the age of 6 years. She then went on to tell me that her first sexual abuse by [REDACTED] took place at her Mother's home in Johnstone when she was 14 years old. Taking into consideration her emotional state of mind. I asked her if she could give me specific details on how these incidents happened.

Georgina stated that she was in the house with [REDACTED] and her Grandmother. Gordon allegedly came into her bedroom and told her that he wanted to have sexual intercourse and proceeded to lie in the bed with her. I asked her why she did not challenge his request and perhaps shout for assistance as her Grandmother was also in the house. She stated that her Grandmother is deaf and would not hear anything. Georgina claimed that [REDACTED] then put his hand over her mouth and asked her to be quiet. He then allegedly raped her.

After this attack, Georgina did say that she told her Mother about it, but apparently her Mother refused to believe her stating that [REDACTED] "would never do such a thing" the issue was never raised again in conversation as Georgina said her Mum did not believe she was telling the truth.

Another alleged rape happened when she and her Mother, [REDACTED] Brothers were in Blackpool sleeping "rough" on the streets. I asked why she never said anything to her Mother about this alleged rape. She said that her Mother has a lot of mental health problems and didn't want to worry her as she has threatened suicide on many occasions and didn't want to add to her poor mental state of mind with extra stress.

The third incident allegedly took place in Callendar. Georgina's Mother, [REDACTED] (Georgina's brother) and [REDACTED] and daughter were all camping in a wooded area.

[REDACTED] had asked Georgina to go with him into the forest to collect wood for a fire. Georgina stated that Gordon then pushed her against a tree and proceed to rape her again.

She also stated that he punched her on the jaw. I asked her again why she did not say anything to her mum or anyone else about this incident. She stated that she was too "scared" I then asked why her Mother did not notice her bruised or cut face. She then said that she did, but [REDACTED] interrupted their conversation by claiming that Gorgina fell over whilst in the forest. Her mother apparently accepted this information as the truth.

Through out this alledged disclosure, the writer was supportive to Georgina's emotional needs. I did explain to her about our "confidentiality procedure" and the seriousness of what she was claiming against [REDACTED] Georgina is adamant that the above incidents are the truth.

Georgina approached me complaining of a sore head. I gave her a cold drink and escorted her back to her bed. I spoke with her regarding her concerns of being unable to sleep. Georgina stated that she was upset with staff over the last few days and that they did not seem to be caring for her. She also discussed with me her concerns of the alleged rape by [REDACTED] She also told me that the police were escorting her back to Callander to where the alleged incident occurred. She disclosed to the writer that this had not been the first time [REDACTED] had raped her. She stated that during the first week of her abscontion [REDACTED] had raped her in his bedroom while at his home in the Johnstone area. The writer asked Georgina if she had discussed this with any other adults she indicated that she had spoken to her mother who was unwilling to take the matter further. Georgina felt that this was because her mother was afraid of physical violence from [REDACTED] Georgina also disclosed that before the alleged rape in Callander she and [REDACTED] had partaken to smoking a joint of cannabis. Georgina also disclosed to me that she had been raped by a [REDACTED] Georgina discussed the

abuse and alleged rapes she suffered at the hands of her stepfather [REDACTED]

[REDACTED] This had started when Georgina was six years old.

At this point [REDACTED] interceded and the conversation came to a close.

I advised Georgina that I was required to discuss this conversation with my line manager and that Georgina could discuss it further with my line manager [REDACTED] in the morning.

On Saturday 21st July 2007 at approximately 5.40 p.m. Georgina approached myself and asked if she could speak to me privately. I then proceeded to take Georgina into her bedroom to allow her to have some privacy. Georgina then burst out crying and disclosed that she has been under a lot of stress recently with an alleged rape by her mother's fiancé namely [REDACTED]

I interrupted Georgina by going through with her, our procedure of "confidentiality". Georgina was prepared to continue with her disclosure. Georgina stated that [REDACTED] not only raped her in Callender but in Blackpool and at her Mother's residence. This allegation apparently happened three months ago. Georgina was also complaining of stomach pain and said she had a thick vaginal charge. I asked her when she last had a "period" but Georgina could not tell me. However, she did say her period was regular but had not had one for a while.

Having discussed this disclosure with my Senior Shift Manager [REDACTED] It was decided in the interest of the young person's health that she should immediately be taken to Crosshouse Hospital.

Georgina was given a pregnancy test, which confirmed that she was NOT pregnant. The duty doctor also examined her stomach area. Georgina declined on having a vaginal smear test. Georgina did agree to have an HIV and Hep C injection. Results will take approximately 6 to 8 weeks. The doctor on duty stated quite clearly to Georgina of what this procedure was for. Georgina was also given paracetamol for headache. (see medical log).

On our journey back from hospital, Georgina disclosed that different men have sexually abused her since the age of 6 years until approx. 11 years.

Georgina had an appointment with the police doctor in Saltcoats at 8pm Thurs 19th July 2007 to disclose information of recent allegations made to staff in Harley Place Children's Unit. Georgina was asked questions regarding recent incidents while on the run with mum in Calendar, Georgina told the police doctor that at the age of 7 & 8 she was sexually abused by several different males. At the age of 11 a gang rape had taken place, a rape took place while being accommodated within a north Ayrshire children's unit by a male resident and while on the run with mum & mum's fiancé ██████████ Georgina disclosed that ██████████ had raped her while they were residing in Calendar approximately one month ago.

After all disclosures were made to the police doctor Georgina was given an examination of the vaginal area, the doctor could tell that sexual activity had taken place but could not tell when and how many times. The doctor felt that the vaginal area appeared to be healthy but advised that an appointment with the STD clinic is made in order for Georgina to be tested for any infections.

I have telephoned the clinic in Ardrossan & at this time I am awaiting on them calling back with an appointment time.

Incident Report 28/8/07

Involving Georgina McMillan

Georgie arrived back at the unit at 9.40pm appearing to be angry with another resident, [REDACTED], whom she'd been out with during the course of the day. When asked the whereabouts of the other resident she said she'd left her with a man. A phone call was made to establish that the other resident was okay and was on her way back to the unit.

When the other resident arrived at the unit upset and went to her room, Georgina appeared to be on edge whilst this was being dealt with and looking for ways in which to have contact with her - which wasn't permitted.

The CID arrived to interview Georgie at 1.30am in regards to an incident relating to the other resident.

They asked her to describe the events of her day and to identify a male from the sheet of mug shots they had, which she did.

They went on to take a formal statement:

She described the male as being just a bit taller than her, of medium build, short dark spiky hair, wearing a ring with a scar on the left of his face. He also carried a mobile phone. *AGED LATE 20s*

Georgie stated that she and the other resident had went out at 3.30pm, returning to the unit at 4.30pm for dinner. Afterwards they went back out into Saltcoats Town Centre and had asked two males for a cigarette in Dockhead Street, close to Farm Foods soon after they had left the unit. One male left the company and they were left in the company of the other, who offered them a drink from a bottle of MD 20-20 (Mad Dog). Georgie said she'd declined though the other resident took him up on the offer. They then went to the rear of the Bank of Scotland and sat with the male on a wall talking.

The male then went and bought a futher carry out, Tennant's Lager for himself and a Bottle of Blue Vodka for the other resident. When asked by the police if she'd taken any alcohol she admitted to having just a sip. She described how she'd had a roll up cigarette and felt funny.

When asked what had happened next, she described how they'd all made their way to The Glebe and sat there. Georgie said she was uncomfortable in the company of the male and had felt on edge - she described how he reminded her of her step dad. She described how the male had cuddled the other resident. Georgie said she'd tried to encourage the

other resident to return to the unit, but she wouldn't come, therefore she returned herself, realizing it was late.

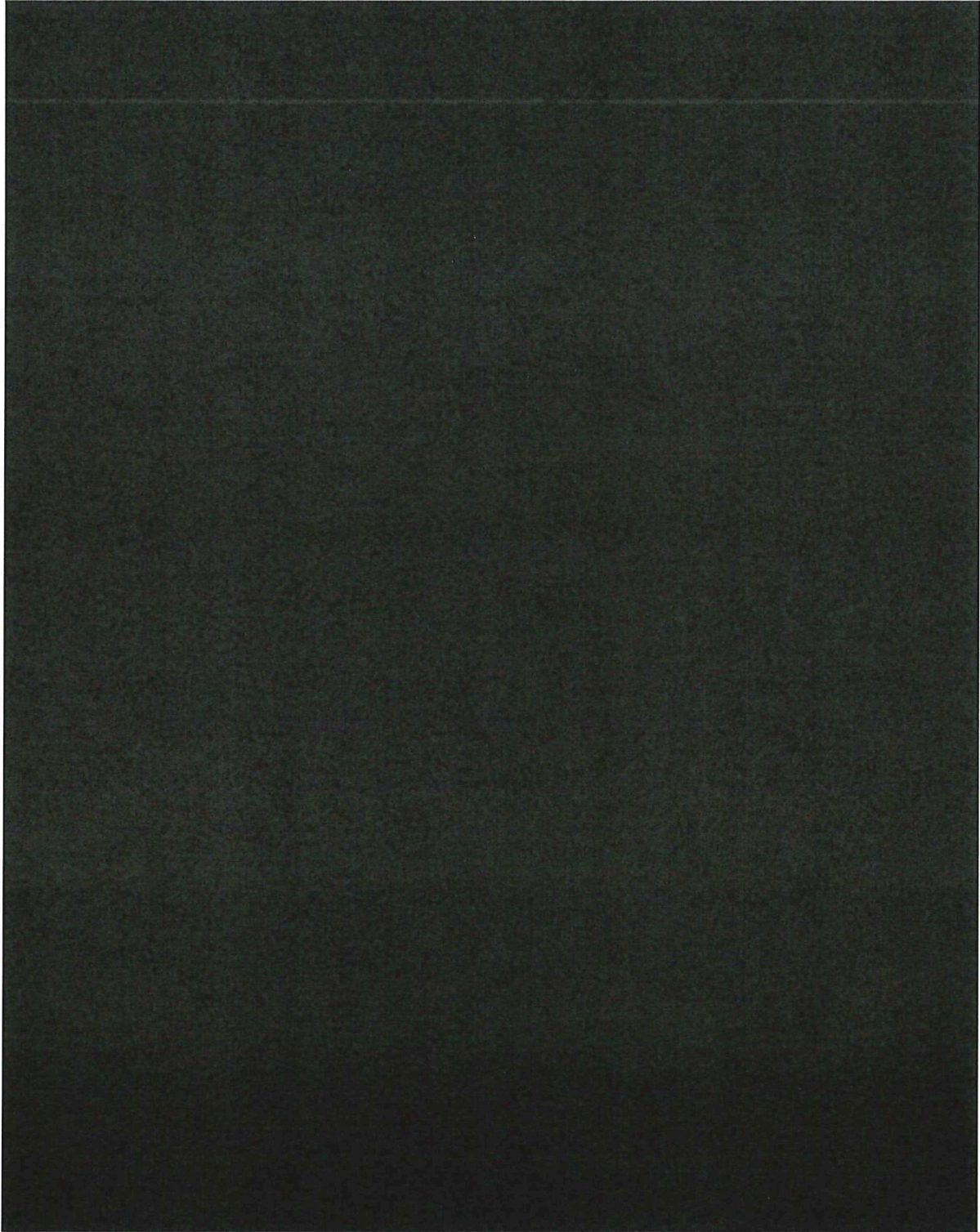
Georgie stated that whilst in the Glebe the other resident had been upset about a dog they'd witnessed being knocked down

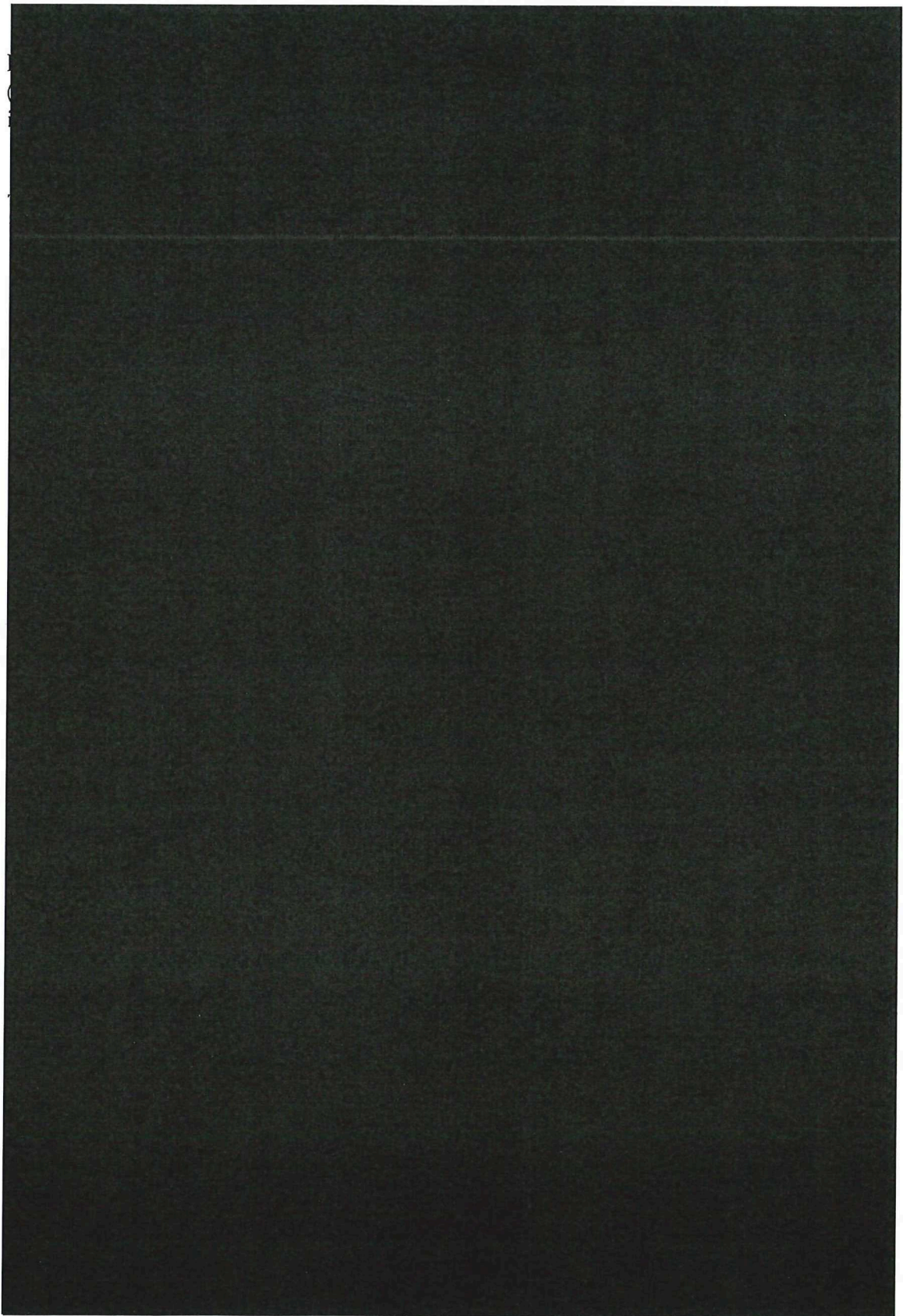

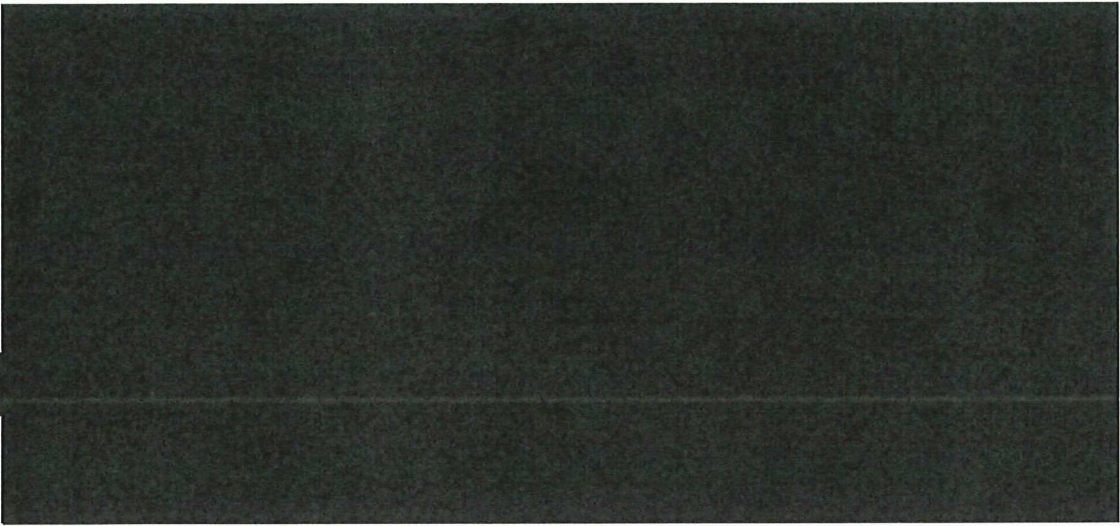

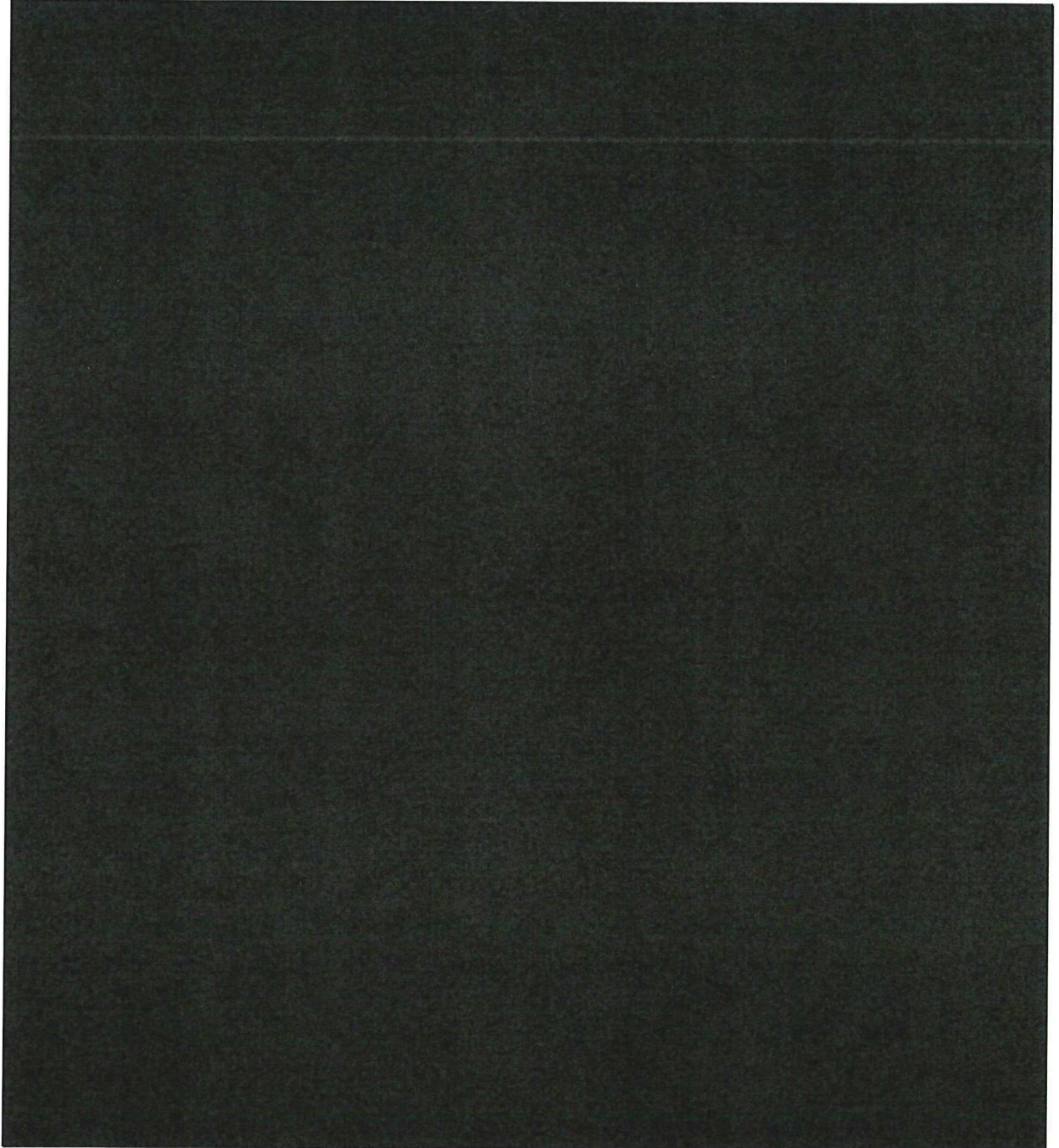

Given the incident that happened on the night of 28/8/07 involving Georgina and [REDACTED] it was decided to hold a planning meeting, given the concerns the incident had raised the indiscrepancies in the girls statements and concerns that [REDACTED] was involved.

[REDACTED] called into the Unit on the night of the incident [REDACTED] was taken to Saltcoats Police Station to give a statement, receive a medical and forensic evidence was taken from the scene. Georgina was interviewed by two CID officers. It was felt there were indiscrepancies between the girl's statements, that they were not concealing information and that they had possibly been at [REDACTED] house.

Information received from another young person resident with Harley Place was that the girls had been at [REDACTED] house and that they had known the male in question from Green Street Hostel.

[REDACTED] had stated he knew Georgina, though she didn't know him. Information received from [REDACTED] did actually know him.

It was concerning that Georgina left [REDACTED] in the males company and returned to the unit saying she felt uncomfortable in his presence. Georgina at this point had still not mentioned they had been a [REDACTED] Georgina had previously made sexual allegation against [REDACTED] and other males in her family circle. Georgina however has absconded and put herself back into risk situation with her family and associates. There was some concern that Georgina may have been involved in grooming [REDACTED] for these associates?

[REDACTED] is currently receiving specialised input to address her sexual and risk behaviour – given [REDACTED] history, it could not be assumed she had been set up by Georgina, as she had put herself in high risk situation before.

Georgina's contact with mother [REDACTED] is still to go ahead. [REDACTED] will be asked to bring some proof of where she is residing as she has been stating she is still residing at the hostel in Glasgow when this is not the case. [REDACTED] may also be using the surname of [REDACTED] at the current time.

The meeting focused on how best to ensure the safety of Georgina and others given the number of allegations Georgina has made and the risk posed by her association with [REDACTED] and however else is within the house.

Decisions:

- 1) To have an early LAC review called to discuss safety issues further.
- 2) Georgina meanwhile to be under high observation and limited movements outwith unit equivalent to a Place of Safety.
- 3) Georgina not to attend the Caley Centre.
- 4) Attendance at Motor Project to be reviewed, possibly halted due to risk assessment – if supervision levels cannot ensure safety for others.
To continue to try and secure placement at Rathbone.
- 5) Risk Assessment within unit to ensure males are not lone working with Georgina.

Update of Information Re: Louise and Georgina

29/8/7 – When [REDACTED] was given the morning after pill, [REDACTED] (Staff) asked if she knew the males' name. At this point Louise said it was [REDACTED]. The description appeared to fit, Jamie was recently released from prison and had been at the unit a couple of weeks previous with his girlfriend, who was making threats towards [REDACTED] is the brother of two of our other residents AF. And LF, with whom he is not permitted any contact. Georgina was out with her Throughcare Worker [REDACTED] in the afternoon – through information being passed over – [REDACTED] (Throughcare) had tried to find out Jaime's current address to discover that he is Remanded in Bowhouse Prison and has been there since 17th Aug.

Both Girls overheard whispering about the incident, and heard discussing what She (??) will do if she finds out about this.

[REDACTED] (LAC Mental Health Nurse) gave unit staff an update after his session with Georgina, as he had informed her of the limitation on confidentiality and Georgina was aware certain information would be passed on. Georgina had stated she had plans to runaway and change her name to Smith.

[REDACTED] also said his interpretation was that Georgina showed no empathy towards [REDACTED]

30/8/7 – [REDACTED] spoke with [REDACTED] who had been with the Georgina and [REDACTED] early in the evening on the 28/8/7. [REDACTED]'s story claimed the girls had been at [REDACTED]'s house with the male. See separate report.

30/8/7 – Professionals Meeting held with regards to Georgina.

30/8/7 – Message left for FACU to contact unit for updated information.

30/8/7 – Georgina confronted and admitted to have being in [REDACTED] house. Also that she was there on Saturday with [REDACTED] (12). Georgina gave wrong address – but showed staff the house, which is [REDACTED]. Staff tried to make contact with [REDACTED] but no response at door.

30/8/7 – [REDACTED] thought the description and information given fitted that of [REDACTED] had previously been warned off having a relationship and contact with. [REDACTED] on checking has been serving a prison sentence since July.

5/9/7 – [REDACTED] at Unit to interview [REDACTED] [REDACTED] again stating that it was [REDACTED] and she had seen him in Kilwinning a couple of days ago. FACU Officer has a suspicion that he may be at liberty and will check this out for definite.
