I refer to the above subject access request for information relating to Stewart Fraser, date of birth 05/12/1969 received by Angus Council 27 April 2026 and passed to us in the Children, Families and Justice Information Governance team for action.

I have checked our Client Index System and our file archive log based on the information provided using names, date of birth, and address. I have also reversed checked his name (Fraser Stewart) in case recorded incorrectly. Angus Council does not appear to hold information on your client.

I note that Mr Fraser currently resides in Dundee area, if this was the same location as his childhood home, the placing authority would have been that which is responsible for his childhood home address - Dundee City Council. This can be checked via this website - <https://www.gov.uk/find-local-council>

I note the connection to Angus is a placement within Rossie School. I should explain that while Rossie School is in Angus, it is not run by Angus Council. It is an independent organisation licensed by Scottish Ministers. We would usually only hold information for your client if Angus Council's predecessor, Angus District Council, had referred your client to Rossie School while they were resident in Angus or if we were required to provide support to the placing authority.

In addition to verifying your client's childhood home address with regards to placing authority, I would recommend you contact Rossie School direct to see whether they hold information for your client. Please see Rossie School's [Freedom of Information](#) webpage. There is a link to their subject access request form towards the bottom of that page.
