Your request for information in respect of your client MRS Sandra Anderson has been forwarded to us to progress as we hold all archive childcare files relating to Angus children.

Can you please confirm Mrs Anderson's birth/childhood surname so we can carry out appropriate checks. As our files relate to a period in a child's life, they only contain their childhood names. I have checked our systems based on the name and date of birth provided and there is no evidence we hold any information based on these criteria.

I should advise however that it is highly likely that we will not hold information relating to your client. I note the connection to Angus is Fornethy House. Whilst located in Angus, Fornethy House was not the responsibility of Angus Council or its predecessors. Glasgow City Council we believe are the contact authority for redress submissions in respect of Fornethy House.

You may be aware of some of the information in the links provided below, however we note within the article from "The Courier" there is reference to some survivors being supported by Thompson's Solicitors in Dundee, not sure it is an option for you to contact them for further information, perhaps to establish if they are now aware of the location of archive files or indeed have access to registration rolls, etc.
