If you require any further information, please don't hesitate to contact us.

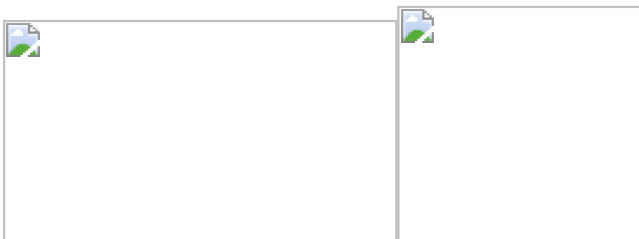
