- (a) [REDACTED] The family have moved around quite a bit "to better themselves". They give the impression of being concerned parents. However, they are clearly experiencing difficulties coping with Lee's behaviour outwith the home.
- (b) [REDACTED] has expressed her concern that the stress and strains of Lee's behaviour - i.e. involvement in offences [REDACTED] do not have a consistent approach in dealing with Lee.
- (c) The family live in a 3 apartment maisonette situated on the top of a 5 storey block of flats. The house is comfortably furnished and well maintained. They have recently returned from Cowdenbeath having lived there for 2 years. Lee was found to be difficult at school there but was evidently not known to the local Social Work Department.
- [REDACTED]
- (d) [REDACTED] were interviewed with Lee. It was explained by [REDACTED] that she had told Lee not to take a carton of lime juice out of the 'packed lunches' cupboard. Lee openly defied her and when she went to grab him to remove him from the cupboard, one of her long nails scratched the side of his eye. The mark is consistent with this explanation and Lee agreed with the explanation, only changing some of the wording.
- [REDACTED] went on to say she felt guilty about the accident and has since cut her nails. She certainly does not consider it as an incident of child abuse. [REDACTED] did state that our concerns could have had some foundation in the past when she was again experiencing difficulties with Lee, but according to [REDACTED] Lee now gets sent to his room or kept in if he has been in trouble.
- (e) Clearly Lee is getting into a lot of trouble and he doesn't seem to realise the seriousness or the possible consequences of his behaviour. His parents are very concerned about
- (f) Lee and welcome the assistance from our Department in an endeavour to effect change in his behaviour and their coping capacity.

Given the stress factors involved in this case, coupled with the fact that there was also a 6 year old child in the family, it was felt that this incident should not be ignored and was therefore dealt with under the Child Abuse procedures. However, in discussion with the family, Mrs Murray, Senior Social Worker and myself were satisfied that the incident was not intentional and that Lee and his brother are not at risk of child abuse. It must be stated though that it is expected that the family will have ongoing Social Work intervention for quite some time to come.
