I ASSURED JORDAN THAT I WOULD DO EVERYTHING POSSIBLE BY SPEAKING TO HIS SOCIAL WORKER AND CHANGING HIS LEAVE TO ALLOW HIM TO ATTEND FT-BALL TRAINING ON A THURSDAY NIGHT. AND JORDAN COULD THEN GO ON LEAVE ON A WED OR FRI. WRITER THE BROUGHT UP THE ISSUE OF JORDAN'S SMOKING NOW THAT MUM HAD GIVEN SMOKING PERMISSION. WRITER EXPLAINED THE DANGERS OF SMOKING TO JORDAN AND THE BAD EFFECT THIS WOULD HAVE ON HIS HEALTH WHICH IN TURN WOULD MEAN THAT HIS FOOTBALL WOULD BE AFFECTED BECAUSE OF HIS LACK OF BREATH STAMMINA. ECT. JORDAN CLAIMED TO HAVE BEEN SMOKING SINCE HE WAS NINE AND IT HAD NOT DONE HIM ANY HARM WRITER EXPLAINED THAT THIS WAS NOT THE CASE ALSO OFFERED TO JORDAN WAS HELP FOR HIM TO STOP SMOKING JORDAN DECLINED THIS OFFER.
