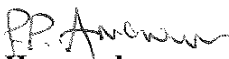

Dear Teresa

I would appreciate you seeing this pleasant girl who experienced child abuse from her stepfather and gave evidence at the age of nine but apparently the incident was thrown out because of lack of evidence as she wasn't keen to talk about it then. However a week ago she went and gave a statement to the Police. She has since then felt very sick, having flash backs and nightmares and sweating episodes. She has good support from her partner but I feel she would benefit from some input as soon as possible just to keep her going through this difficult time and teach her some coping mechanisms. She has asthma so I haven't been able to give her any Propranolol and at the moment she is reluctant to take any medication, although I have given her ten 2 mg Diazepam for emergency use.
