She was later found to have written graffiti on the walls and was subsequently suspended for 10 school days.

Mandy's behaviour is continuing to border on the unacceptable. Her recent escapades have put her at serious risk.

The placement with Mr. & Mrs. Fraser has always been seen as a permanent one. However, Mandy has now put the placement at serious risk of complete breakdown. If Mandy does not make a considerable effort to co-operate at school, then alternative schooling would have to be looked at and this alone could jeopardise the placement.
