Fife Council has been unable to locate any care records relating to Miss Mcculloch.

We made enquires with both Social Work and Archive Services who completed a thorough search of their archives and digital databases, no information was found.

Social Work records pre-1990, were often created as family files rather than individual files, and so your client's data may not be held under their own name, but under a family members name. We would be happy to carry out further searches if you are able to provide additional family details of your client, including parents and any sibling's names, and their dates of birth.
