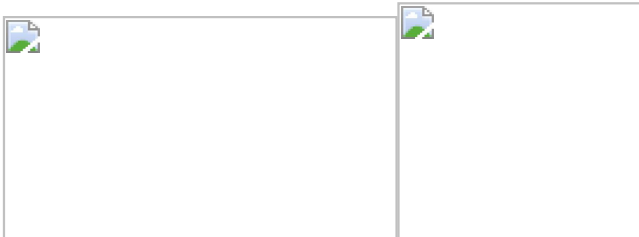

Thank you for your subject access request on behalf of your client, Ms Alexander.

Your request

You told us your client was adopted in 1982 by Mr and Mrs Adam and Eve Alexander.

Response to your request

National Records of Scotland (NRS) holds records of adoption that took place in Scotland.

My colleague from Adoption Unit carried out a search and confirmed that Nicola Ann Alexander does not have an entry in the Adopted Children Register for Scotland.

They have also checked her birth record, and there is no annotation indicating adoption. As all birth records are updated following an adoption, this further confirms that Ms Alexander was not adopted in Scotland.

On that basis, we would not hold any adoption-related records for Ms Alexander.
