We.transfer is a free and efficient way of sending files electronically that struggle through email as it compresses the file size so as to allow it to fit into an email.

You would input our email address, your email address, and the body of the email and then attach a file or folder and send it over. We would then receive a link to follow and would then be able to download it.

You get a handful of free transfers and then you will have to pay. This is also an encrypted service, so our document transfer is completely secure.
