Notes on Place of Safety warrant

SOCIAL WORK (SCOTLAND) ACT 1968, Part III - Children who may need compulsory measures of care.

Section 30(1) - Definition of "a child" - for the purposes of a Place of safety warrant:

- (a) a child who has not attained the age of 16.
- (b) a child over the age of 16, who is not yet 18 and who is subject to a supervision requirement under the Social Work (Scotland) Act 1968.
- (c) a child whose case has been referred to a children's hearing under Part V of the Social Work (Scotland) Act 1968.

CHILDREN ACT 1975, SECTION 83(b) - detention of children in places of safety.

A constable or any person authorised by any Court or any justice of the peace may take to a Place of Safety a child coming under any one of the categories overleaf. When the child has been taken to a Place of Safety, he may be detained there until arrangements can be made for a children's hearing. The constable/authorised person/occupier of the Place of Safety shall forthwith inform the reporter of the case.

Also under the SOCIAL WORK (SCOTLAND) ACT 1968, SECTION 37(3), the child shall not continue to be detained under the Place of Safety warrant:

- (a) where the reporter considers the child is not in need of compulsory measures of care
- (b) after the date on which a children's hearing considers the child's case
- (c) for more than 7 days.

SOCIAL WORK (SCOTLAND) ACT 1968, SECTION 94 - definition of a "place of safety"

"Place of Safety" means any residential or other establishment provided by local authority, a police station, or any hospital, surgery or other suitable place, the occupier of which is willing temporarily to receive a child.
