First memories of being taken into care I was scared and nervous and upset being taken from siblings but walso a relief at the the same and time at the age of 10 I was taken too Carsewod house , healthfit drive , howwood scotland , the only way to describe this is an institution , the matron that was in charge mrs crusick she was horrendous catholic women, she didn't like me from the get go , you did not dis agree with her , she likes to give me disciplinary , she would scream and shout at us I would watch her beat my young brother when he come into the care home this was so upsetting for me to watch I felt guilt as there was nothing I can do , this was upsetting as I was watching this at home by my father I knew we hadnt escaped it , the staff would always assist us to the baths and stand there and watch us , this would happen on a regular basis , food was an option but we didn't enjoy what was provided the food was strict we wasn't allowed to drink until the plate was empty , if we didn't like it we was force fed or we wasn't allowed a drink , they would punish us for elbows on the table , I would watch them restrain other children with o much force I was to scared to even step out of line , there was other staff who would pick at us miss watts she would call us names and push us around the corridors , the staff never smiled at us or made us feel safe they would scream and push us they was so cold all I wanted was to feel loved ,she would frighten us all , a lot of the time I would be sent to my room and kept in there for the night , there was a lot going on in there and they turned a blind eye to it there was other children running wild and left to them selfs and I was sexually assaulted on a few occasions by a male child who was a few years older than me he was Matthew I will never forget his name or his face , it got to the point I gave up I new there was no escaping the abuse , they would call me unwanted and tell me no one wanted us , they would allow my dad to come up once a fortnight but if he was drunk they would stop us seeing him which I understand but they would let us all know in front of the children whilst laughing , they allowed my mum to come and see uf a few times and after a few years my mum took my siblings home and I was just left here I have always felt neglected and unwanted and in this care home they would remind me of this daily , I was a bed wetter till around 8/9 I couldn't control my nervous I was a nervous wreck , they would embarrass me for this , I was here untill the age of 16 being mentally tormented , being physically abused and sexually my life was over I felt like I had no one and noone cared to listen to me , she is very upset still tile this day everyday is a struggle and she struggles with anxiety , PTSD , DEPPRESION AND DOESN'T TRUST ANYONE AND BUILD RELATIONSHIPS
