Ailsa Children's Home, Highland, where I stayed for around three years. This was not the worst placement, but I was completely alone with my thoughts and had no support. I was struggling mentally but had no one to explain to me why I felt the way I did. During my time at Ailsa, I experienced both mental and physical abuse. I was restrained frequently by staff, often using excessive force, which caused me a lot of physical pain. Staff would speak to us very badly and treat us with no respect, but at the time I believed this was normal. There was a lot of fighting between children, constant violence, and severe bullying from other residents, which was often ignored and they were allowed to get away with it. I was locked away a lot and became very withdrawn and isolated. I had no one to help me, and my mental health deteriorated significantly during this time.

After three years, just before I turned 14

in Carelaw Care Home in Stevenson, where I stayed for around one year. This is where the abuse became extremely serious, and I immediately knew I was not safe. On the first day I arrived, I was stripped naked by staff and beaten. A staff member named Stewart Nickson broke my jaw during this assault. I was never taken to hospital. Instead, I was kept in the home and prevented from seeing visitors for a period of time to hide what had happened. To this day, my jaw is still damaged and causes ongoing problems.

That first day marked the beginning of daily physical abuse. I was beaten regularly by staff. I remember staff coming into my room, folding me up on my sofa bed, and beating me so badly that my bed was broken during the assault. I was suffering severely and lived in constant fear.

On one occasion, I banged my leg on the broken bed, which ripped my leg open and exposed the muscle. Staff refused to take me to hospital and instead used super glue to close the wound. I still have the scars from this injury today.

Staff constantly watched us and would drag us to the baths, saying they had to wash us. This was humiliating, painful, and deeply distressing. I also witnessed this being done to other children. A staff member named Matt Neil would take us to his house and touch us. I never allowed him to touch me, and because of this, I was beaten again.

Every night, I was locked in my bedroom. Home leave was used as a form of control and punishment, and despite my behaviour, I was never given home leave. I was dealing with this abuse daily, and my mental health completely deteriorated. I felt broken, terrified, and trapped.

After around a year, at the age of approximately 14–15,

I was moved to The Kibble, Paisley, where I stayed for around one and a half years. When I first arrived, the environment was chaotic, with children running riot, but staff seemed aware of how traumatised I was from my previous placement. I didn't mind being there and eventually settled. I felt relieved and grateful to be away from Carelaw.

After one and a half years, I was moved to St John's for around one month while social workers were holding meetings behind my back to send me back to Carelaw. When I found out, I was absolutely terrified and horrified at the thought of returning there. I ran away because I was too scared to go back. At the age of 15–16, I refused to return, and eventually I was placed back in care with my mum.

The impact of my time in care has affected me for my entire life. I continue to struggle severely with my mental health. I suffer from anxiety, PTSD, and depression, and I still carry physical scars and vivid memories from the abuse I endured. I have ongoing physical issues, including permanent damage to my jaw, and lasting scars from injuries that were never treated properly. I cannot control the way my mental health has been impacted by what I went through. The abuse, fear, violence, and neglect I experienced throughout my time in care have had a devastating and lifelong effect on me and have ruined my quality of life.
