I remember my time at Lendrick Muir as a period of constant fear, confusion, and pain. From the moment I arrived, I felt powerless and alone. Instead of being cared for and protected, I was subjected to daily abuse by the house teacher. He would hit me every single day. Sometimes it was punches, other times slaps or kicks. It didn't matter what I had or hadn't done — there was often no reason at all. The violence felt random and unpredictable, which made it even more frightening. I was always on edge, never knowing when the next blow would come.

The physical abuse was relentless. I can still remember the shock of being struck, the pain spreading through my body, and the humiliation of being treated as if I wasn't a human being. Being punched and kicked by someone who was supposed to look after me left me feeling worthless and ashamed. I started to believe that I must deserve it, because it happened so often and no one stepped in to stop it. There was no safe adult to turn to. I felt trapped.

Alongside the physical violence, I was subjected to severe neglect. I was regularly locked in my room and left there for long periods. It felt like imprisonment. I would be isolated with my thoughts, frightened and confused, with no comfort or reassurance. Being locked away like that made me feel completely abandoned. I wasn't given the care, attention, or emotional support that any child needs. Instead, I was ignored and left to cope on my own.

The neglect wasn't just about being left alone physically — it was emotional too. I felt invisible. My feelings didn't matter, my fears didn't matter, and my wellbeing didn't matter. I lived in a constant state of anxiety, always waiting for the next incident. I struggled to sleep because I was afraid. I struggled to trust anyone because the person responsible for my care was the one hurting me.

Over time, this treatment deeply affected my mental health. I became withdrawn and fearful. I felt hopeless and helpless, as though there was no way out. The daily abuse broke down my confidence and self-esteem. I felt small, insignificant, and undeserving of kindness. The trauma of being hit and kicked so regularly, combined with being locked away and neglected, has stayed with me long after leaving Lendrick Muir.

What I experienced there was not discipline — it was sustained physical and emotional abuse. I was a child in care who needed protection, guidance, and compassion. Instead, I was subjected to violence and neglect on a daily basis. The impact of that time has followed me into adulthood, affecting my mental health, my relationships, and my sense of safety in the world.

Even now, I carry the memories of that fear and pain. The experience left deep emotional scars as well as physical ones. Being abused and neglected in a place that was meant to keep me safe has had lifelong consequences for me.


