I was a vulnerable child who needed protection, who needed love, who needed someone to fight for them. Instead, the people at Cardross children's home — the people who were supposed to care for me — became the very monsters I needed protecting from.

What they did to me was barbaric. They abused me, physically and mentally, over and over again. There was no escape, no relief, no end to it.

They lined me up naked for showers, exposed and humiliated, robbing me of every last piece of dignity I had. And then they hit me. They hit a child. Repeatedly, without remorse, without hesitation, as if I was worthless. As if I was nothing.

I remember the fear. The kind of fear that seeps into your bones and never truly leaves. I had nobody. Nobody to hold me, nobody to tell me it would be okay, nobody to wipe my tears or fight my corner. I was utterly alone in the worst moments of my young life.

And as if my own suffering wasn't enough, I was forced to watch other children endure the same nightmare. Children just like me, scared just like me, with nobody to save them either. Those memories are burned into me. I can close my eyes right now and still see them. Still feel the helplessness of standing there, unable to do anything, just a child watching other children break.

It never left me. How could it? You don't just walk away from something like that. It followed me out of those doors and into every single day of my adult life. It is there when I wake up in the morning. It is there when I try to let someone in and find that I simply cannot, because trust was stolen from me before I even had the chance to understand what it was. It is there in the anxiety that grips me, that suffocates me, that makes even the simplest things feel impossible. It is there in the darkness of my mental health, in the battles I fight inside my own mind that nobody else can see.

I have carried this weight my entire life. A weight that was placed on me by adults who chose cruelty over compassion, who chose power over protection, who looked at a child and saw someone they could hurt without consequence.

I was let down in the most profound and unforgivable way. I deserved safety. I deserved kindness. I deserved a childhood. They took all of that from me, and I want the world to know what they did.

A child with a whole life ahead of me, a child who needed nothing more than to feel safe, loved and protected. But Belfield Home took all of that away from me. It didn't just take my childhood — it took a part of my soul that I have spent my entire life trying to recover.

The staff — the adults who were supposed to be my caregivers, my protectors, the people my life was placed in the hands of — they abused me. Sexually. Physically. Mentally. Over and over again. I was so small, so frightened, so utterly powerless. I didn't understand what was happening to me. I only knew that it was wrong, that it hurt, and that no one was coming to stop it.

And in the middle of my own suffering, I was forced to watch them do it to other children too. Other little ones, just as scared and just as helpless as I was. I watched and I could do nothing. Nothing. That helplessness has never left me. The faces of those children have never left me. In my darkest moments, I still see them.

What was done to us in that place was evil. There is no other word for it. The years have passed, but the wounds have never healed. My mental health has been in tatters for as long as I can remember. I have fought battles inside my own mind that most people could never imagine. I have struggled to feel worthy of love, struggled to trust another human being, struggled to believe that the world is a safe place — because the first place that was supposed to be safe for me was anything but.

I grieve for the child I was. I grieve for the childhood that was ripped away from me. I grieve for every single child who suffered in that place, whose cries went unheard, whose pain went unseen. We deserved so much better. We deserved to be protected.

We deserved to be loved, And I will not stop speaking my truth until every person responsible for what happened in Belfield Home is held accountable
