The mental and sexual abuse I went through happened on a few occasions, but even those few incidents were enough to leave a lasting mark on my life. At the time, I didn't fully understand why it was happening or how deeply it would affect me later on. What I do know is that those moments changed the way I see myself, the way I trust people, and the way I move through the world.

The mental abuse made me feel small, confused, and constantly on edge. Being spoken to or treated in ways that made me doubt myself became something I carried inside, even long after the incidents stopped. It created a sense of fear and uncertainty that I still struggle with today. The sexual abuse added another layer of trauma — something that no one should ever have to experience. Even though it happened on a few occasions, the impact has been long term. Those moments left me feeling exposed, powerless, and unsure of my own safety.

These experiences have affected my life massively. I suffer from flashbacks that bring me right back to those moments, sometimes without warning. It can feel like I'm reliving it, even though I know I'm not there anymore. The anxiety that comes with these memories makes day to day life difficult at times. Simple things can become overwhelming, and there are days when just getting through feels like a challenge.

I struggle with this every day. The emotional weight of what happened doesn't just disappear — it stays with me, shaping how I think, how I react, and how I cope. It gets me down, and it affects my confidence and my ability to feel safe around others. Even though the abuse happened years ago, the effects are still very real in my life now.

Talking about this is not easy, but it is part of acknowledging what I went through and how it continues to affect me. These experiences were not minor or forgettable — they were traumatic, and they have had a significant impact on my mental health and my daily life. This is my reality, and I am still learning how to manage the long term consequences of what was done to me.

The mental and sexual abuse I experienced at this place went on for years, for as long as I was there. It wasn't just a single incident or something that happened occasionally — it was a constant part of my life during that time. Looking back, I can see how deeply it affected me, but at the time I was just trying to survive each day and make sense of why the people who were supposed to care for me were the ones causing me harm.

The mental abuse wore me down slowly. It made me question myself, my worth, and whether I deserved any better. Being spoken to in ways that belittled me, intimidated me, or made me feel powerless became normal. Over time, it chipped away at my confidence and left me feeling small and unsure of myself. Even now, I still struggle with the impact of those words and the way they made me feel. It's something that has stayed with me into adulthood, affecting how I see myself and how I interact with others.

Alongside the mental abuse, I also suffered sexual abuse that continued over a long period. The inappropriate behaviour, the comments, and the way I was treated left me feeling exposed and unsafe. It wasn't just the physical actions — it was the constant fear, the sense of being watched, and the knowledge that there was no real protection for me. Living with that kind of fear at such a young age changes you. It affects how you trust people, how you form relationships, and how you feel in your own body.

These experiences have had a massive impact on my life. They still get me down, even now. I carry the emotional weight of what happened, and there are days when it feels overwhelming. The long term effects of the abuse have shaped my mental health, my confidence, and my ability to feel safe around others. It's difficult to explain how something from so long ago can still feel so present, but the truth is that the trauma doesn't just disappear. It becomes part of you, and you have to learn how to live with it.

Speaking about this is painful, but it's also important. Acknowledging what happened helps me understand why I feel the way I do and why certain things are still so hard for me. This wasn't just a difficult period — it was years of abuse that changed the course of my life, and I am still dealing with the consequences today.
