How to complete this section

I remember clearly a member of staff at the home called Ricky Pindle. He would constantly remind us that he was a boxer, and he used that as a way to intimidate us — making it clear that if we did not do as he said, there would be consequences. He was in his fifties or sixties, and the power he held over us felt very real and very threatening.

One morning, I witnessed him approach a boy called Robert completely unprovoked and hit him with a mop. There was no reason for it. Watching that happen made me feel afraid in a way that is hard to describe — because if that could happen to someone else without cause, I knew none of us were safe.

Ricky also had me placed in a secure room. There were no handles on the door, and I had no way of getting out. I was kept in that room for a week. Food was passed through the door, but I was not allowed water. I was forced to sleep on a mattress on the floor. Being confined like that, alone and without even basic necessities, was one of the most distressing experiences of my time there.

The only person I can look back on with any warmth was a man called Mr McKenzie, who worked the night shift. He was kind to us, and he would give us cigarettes. In an environment where cruelty and control felt like the norm, his decency stood out. He was the only member of staff I felt I could be around without fear. Out of six male and two female members of staff, he was the only one who treated us like human beings.

What made everything harder to bear was knowing that I should never have been there in the first place. I was sent to that home simply because I had not been attending school. My parents did not want me to go. They fought against it, and I hated every moment of being there.

The isolation was relentless. We were not permitted to mix with one another unless staff allowed it, which only deepened the loneliness I already felt. One night, the desperation became too much and I ran away in my nightgown. I hitchhiked eighty miles. My social worker came the following day and brought me back. I did not get on with my social worker at all, and I never felt that she was on my side or truly acting in my best interests.

The punishment did not stop there. If I misbehaved, I was starved. When my mother brought food for me, it was taken away. There were also times when my parents were stopped from visiting altogether, which devastated me every single time it happened. Those visits were something I held onto, and having them removed felt like yet another way of breaking me down.

The attitude of the staff was one of superiority. They treated us as though we were beneath them, and that atmosphere made it impossible to open up or ask for help. The only exception was Mr McKenzie. He was the only one I could ever let my guard down around, even slightly, and I have never forgotten his kindness.
