I was restrained quite forcefully, and the way it was done felt completely over the top. It was carried out by both male and female members of staff, and the physical pressure they used caused real pain in my arms and legs. Sometimes they would even sit on top of me, and I remember one man in particular who was very heavy. He would lean over me, and his breath was right in my face. The whole experience made me feel powerless and humiliated.

They would also speak to me in a really harsh and degrading way. They shouted directly in my face, and I often felt isolated, confused, and overwhelmed. Those moments have stayed with me throughout my life. The emotional impact didn't end when I left; it followed me into adulthood. I have struggled with my mental health ever since, and I ended up on antidepressants for most of my life because of the way I was treated there. It shaped how I saw myself and how I coped with the world.

There were also times when staff members came into the room and made me give the women massages using baby oil. I remember one woman in particular, Franny. She was the one who stands out most in my memory. During these situations, she touched me in ways that made me extremely uncomfortable, including touching my lower body. It wasn't just her—there were a few female staff members involved. I was a child, and I didn't understand what was happening or how to respond. I only knew that it felt wrong, confusing, and deeply uncomfortable. The way they acted towards me left me feeling ashamed and unsure of myself, and it has affected how I relate to my own body and to other people even now.

Looking back, I can see how these experiences shaped so much of my emotional life. I carried the confusion, fear, and shame with me for years. Even today, I still feel the weight of what happened. It wasn't just physical restraint or unkind words—it was a loss of safety, dignity, and trust at a time when I was vulnerable and needed care.

There was an arcade game that was a football game, and I remember a teacher, Matt George, pushing himself up against me from behind while I was playing it. That moment has stayed with me because it felt so wrong and confusing, and I didn't understand why an adult would behave that way toward me. It left me feeling uncomfortable and unsure of myself at an age when I should have felt safe around the people responsible for looking after me.

We would also be in the PE room, and the teachers would throw golf balls at us. This happened every week. Sometimes they missed, but a lot of the time they didn't. I remember feeling scared and tense, never knowing when it would happen or how hard it would be. From memory, one of the teachers involved may have been called Harry, although I'm not completely certain. What I do remember clearly is the fear and confusion I felt, and how normalised this behaviour became in that environment.

We were spoken to very badly, often shouted at or belittled. I was restrained by teachers more than once, and each time it left me feeling powerless and overwhelmed. I was in a unit called Fleming 1, and one of the teachers there made me fight the hardest boy in the class. I didn't want to, but I felt like I had no choice. I ended up very badly bruised, and I had a black eye afterwards. I also remember being stabbed with a fork by one of the pupils. All of these experiences built up over time, leaving me feeling unsafe, confused, and constantly on edge.

These events have had a long lasting impact on my mental health. I have struggled for many years with the emotional consequences of what happened. The fear, humiliation, and lack of protection I experienced have followed me into adulthood. I am now on antipsychotic medication as well as antidepressants, and I know that much of this stems from the way I was treated during that period of my life. The memories still affect me, and I continue to work through the emotional weight of everything I went through.


