The abuse I experienced in that place was mainly mental, but it had a deep and lasting impact on me. One of the things that still affects me now is how the staff allowed other children in care to come into my room and move my things around. They would interfere with my belongings, pin things on my door, and make me feel like I had no privacy or control over my own space. It might sound small to someone who hasn't lived through it, but when you're a child in care, your room is the only place where you should feel safe. Having that taken away from me made me feel targeted, unsettled, and constantly on edge. It created an environment where I never felt secure, and that feeling has stayed with me into adulthood.

There was also a man there who made me feel extremely scared and uncomfortable. He liked the girls to touch him, and he would get massages from other girls right in front of me. Watching that happen made me feel frightened and confused. I didn't fully understand what was going on at the time, but I knew it wasn't right. I remember feeling frozen, not knowing what to do or who to tell, and feeling completely unprotected. Being exposed to that kind of behaviour as a child left me feeling unsafe in a place where I should have been cared for.

These experiences may have happened years ago, but the emotional impact has stayed with me. The constant mental pressure, the lack of safety, and the inappropriate behaviour I witnessed all contributed to a deep sense of fear and mistrust. It affected how I saw myself and how I saw the people around me. Even now, I struggle with the long term effects. I find it difficult to relax around others, and I often feel anxious in situations where I don't feel fully in control. The memories of what happened still come back to me, and they can be overwhelming at times.

Talking about this is difficult, but it is important for me to acknowledge the reality of what I went through. The mental abuse, the lack of protection, and the frightening situations I witnessed have all shaped the person I am today. These were not minor incidents — they were experiences that took away my sense of safety and left emotional scars that I am still learning to manage.

The staff would physically restrain me, but the way they did it was completely over the top. They would sit on top of me and on top of other girls, using far more force than was ever necessary. Being held down like that made me feel terrified and powerless. Instead of calming a situation, it made everything worse. I remember feeling trapped, unable to move, and completely at the mercy of adults who were supposed to protect me. Those moments left me shaken and unsure of my own safety in a place where I should have been cared for.

There was also a situation involving Steven, who was in a relationship with one of the other girls in care. I witnessed this, and it was something no child should ever have to see or be involved in. I ended up having to go to court because of it, which was incredibly frightening for me. Being so young and having to face something so serious left me feeling overwhelmed and deeply uncomfortable. I didn't fully understand everything that was happening, but I knew it wasn't right, and it added to the fear and confusion I was already living with.

On top of all of this, there was emotional abuse that affected me every single day. I would be locked in my room, left alone with my thoughts and fears. Being shut away like that made me feel isolated and punished, even when I hadn't done anything wrong. It took away any sense of security I had and made me feel like I didn't matter. The emotional impact of being locked in my room, combined with the physical restraint and the things I witnessed, has stayed with me throughout my life.

These experiences made me scared, uncomfortable, and constantly on edge. They shaped how I saw myself and how I saw the people around me. Even now, the memories still affect me. The fear, the lack of safety, and the emotional pressure I lived under have had a long term impact on my mental health and my ability to trust others. What happened to me wasn't just a series of incidents — it was a pattern of mistreatment that has left lasting emotional scars.
