Looking back now, one of the most painful things I can reflect on is not just what was done to me, but what I believed about myself because of it. When they attacked me, I thought I deserved it. I had been treated so poorly for so long, and had been made to feel so worthless, that the abuse felt like something I had brought upon myself. That is what prolonged mistreatment does to a person — it distorts the way you see yourself, until you can no longer distinguish between being punished and simply being who you are. I was a child, and no child deserves to be made to feel that way.

I was locked in a room regularly, with no freedom to come and go. Being confined in that way was not only physically restrictive — it was psychologically damaging. The walls of that room came to represent everything I felt about my situation: trapped, powerless, and without any means of escape.

On top of the confinement, meals were skipped quite regularly. This was not accidental or due to poor organisation — it happened often enough that it could only have been deliberate. Being denied food is a particularly cruel form of control, because it targets something so fundamental. Hunger is hard to ignore, and knowing that others had the power to withhold even that from me reinforced just how little agency I had over my own life.

The physical abuse I experienced was severe. Male members of staff would restrain me and beat me. They would drag me out of my room and subject me to violence that left me bruised all over my body. There was more than one of them, and there was only one of me. The imbalance of power was absolute. These were adults who were supposed to be responsible for my welfare, and instead they used their size and authority to cause me physical harm.

The bruises would fade, but the memory of how they were inflicted has not. Being beaten by people in a position of trust and care is a particular kind of betrayal, one that affects far more than just the body. It affects your sense of safety, your ability to trust others, and the way you come to understand your own value as a person.

I carried the belief for a long time that I had deserved what happened to me. Unlearning that has been one of the hardest parts of processing these experiences. The truth is that I did not deserve any of it. No child does. What was done to me was wrong, it was abusive, and the responsibility for it lies entirely with the adults who chose to treat a vulnerable young person with violence and cruelty, rather than with the care and protection that was their duty to provide.

I was attacked in there by the staff, and it happened more than once. They would rip our clothes off and make us lie in the room naked, and this became a regular thing. Every time it happened, I felt terrified, ashamed, and completely powerless. No child should ever be put in that position, and yet it became part of my daily reality. The humiliation and fear from those moments have stayed with me throughout my life.

There was a supervisor there who made everything even worse. He was a professional boxer, around 6ft 5 and about 19 stone, and he would beat us up on purpose. Knowing someone that physically strong was allowed to treat us like that made me feel constantly on edge. His presence alone was intimidating, but the violence he used was something I could never forget. His name was Mr Cowie, and he was the worst one. He really took things out on the young lads. You could hear them screaming, and you could hear the sounds of them being beaten. Those sounds still echo in my mind.

I spent time in segregation, and that experience was just as frightening. I would get beaten up and then left in there for months at a time. The normal staff didn't come down there, so it felt like we were completely cut off from the world. Being isolated like that, especially after being attacked, made me feel abandoned and hopeless. I remember sitting there for long stretches of time, not knowing when someone would come or what would happen next.

Hearing the other boys being hurt, knowing it could be me next, and feeling like there was no escape created a constant sense of fear. It wasn't just physical pain—it was the emotional impact of being treated like we didn't matter. The lack of safety, the humiliation, and the violence all built up inside me.
