I was abused and neglected from a very young age. I was taken away from my mother when I was small, and I have only vague memories of being in and out of care before my earliest clear recollection, which is being placed in Coylton Home at 8 Woodhead Road. I believe I was around three or four years old at the time. This was where my abuse began and where I first learned that I was unsafe and unwanted.

When I first arrived at Coylton Home, some of the staff appeared kind, but it did not take long for me to realise that this was not a safe place. As a very young child, I witnessed staff sexually assaulting children in the home. I did not fully understand what I was seeing at the time, but I knew it was wrong and frightening. Some staff members were physically rough with us, pushing us around, restraining children, and calling us names. We were regularly humiliated and treated as if we did not matter.

There were staff who were inappropriate and “touchy-feely” with us. They would touch our hands, faces, shoulders, and bodies in ways that made me uncomfortable and confused. I was exposed to sexual behaviour far too young, and I believe I was being groomed, even though I did not have the words for it then. I lived in constant fear.

There was a lot of violence in the home. Children were made to fight each other, and staff allowed it to happen. We were constantly scared, not only of the staff but of one another. There was no comfort, no protection, and no one to turn to. I was left to fend for myself emotionally and physically at an age when I should have been cared for. I remained in this environment for around three years, feeling abandoned, neglected, and completely alone.

After this, I was placed with a family called the Walkers in Barrassie. I was still very young, and although I believe this placement was calmer, I cannot remember much from this time. I was there for around a year. My lack of memory reflects how young and disconnected I was by this point in my life.

At around six or seven years old, I was moved back to Coylton Home for a few months. I remember feeling deeply unwanted. The abuse continued. Staff laughed at me, called me names, and encouraged violence between children. I was made to fight other children. This continued for around a year, and by this point, I felt worthless and scared all the time.

At around eight years old, I was placed with the McNaughts family in Ballantrae, who lived on a farm. For a short time, this felt closer to a normal life, but it did not last. The woman in the household frequently used physical punishment, hitting me with her hands. This made me frightened to speak up or express myself. I learned to stay quiet and keep to myself to avoid punishment. I lived in fear here and internalised the belief that my voice did not matter. I remained here until I was around eleven years old.

I was then placed back into Coylton Home again for a few months. Nothing had changed. I was beaten, bullied, and emotionally abused. I hated being there and felt completely trapped. After a few months, I was moved again

I was then placed with the Opies family. From the very beginning, this placement was distressing. I was forced to attend church, and when I refused, I was physically restrained. I was made to call the woman "mum," but her children bullied me, laughed at me, and told me she was not my real mother. I was treated differently from her children in every way.

While living there, attempts were made to force me to change who I was, including trying to make me present as a girl. This was deeply confusing, frightening, and damaging to my sense of identity. I was terrorised in this household. I was isolated, often made to eat alone, and deliberately left out. I felt like an outsider, a burden, and a loner. The mental torment was constant. I was left alone with my thoughts, which became darker over time. I remained there until I was around fifteen or sixteen years old.


