When I look back on my childhood, one of the things that affected me most was the mental abuse I experienced. I was made to feel as though everything that had happened to me was my own fault. I was told, directly and indirectly, that the reason I was in care was because nobody wanted me. Hearing that as a child, and feeling it repeated through people's actions and attitudes, shaped the way I saw myself for years. Instead of feeling supported or protected, I grew up believing I was the problem, that I was unwanted, and that I somehow deserved the situation I was in.

Being made to feel responsible for things that were never my fault created a deep sense of shame in me. I carried that shame into my teenage years and adulthood without even realizing how much it was influencing my thoughts and behavior. When you are repeatedly told that you are unwanted, it becomes something you start to believe. I internalized those messages, and they became part of how I understood my place in the world. I felt like I had to prove myself constantly, yet at the same time I doubted whether I was worth anything at all.

This had a massive knock on effect in my adult life. Trust became something incredibly difficult for me. I found it hard to believe that people genuinely cared or that their intentions were sincere. Even when someone showed kindness, there was a part of me that questioned it, wondering if it was temporary or if they would eventually leave like I had been led to believe everyone would. That constant fear of being abandoned or rejected made it difficult for me to open up or rely on anyone.

My relationships were affected as well. I struggled to let people get close to me because I was always preparing myself for the possibility that they would walk away. I often kept my guard up, even when I didn't want to. The emotional impact of being made to feel unwanted as a child followed me into every stage of my life, shaping how I connected with others and how I saw myself.

Speaking about this now helps me acknowledge the truth of what I went through. It allows me to recognize that the blame I carried for so long was never mine to hold. Understanding that has been an important step in trying to rebuild my sense of self and learning, slowly, that I deserved better than the way I was made to feel.

When I think about my time in foster care, one of the most damaging parts of my childhood was the abuse I experienced from my foster father. He was abusive sexually, mentally, and physically. Even now, it is difficult to fully express the impact this had on me, because it affected every part of who I became. As a child, I didn't understand why it was happening or why someone who was supposed to care for me could treat me that way. I only knew that I felt unsafe, confused, and constantly on edge. Those experiences left deep emotional wounds that I have carried into adulthood.

The mental abuse made me question my worth and my place in the world. I was made to feel small, powerless, and undeserving of kindness. The physical abuse reinforced that fear, teaching me to expect pain rather than protection. The sexual abuse created a level of trauma that I struggled to even acknowledge for many years. It left me feeling ashamed and isolated, as though I had to carry the burden alone. These experiences were not isolated moments — they became part of my daily reality, shaping how I saw myself and how I understood relationships.

The impact on my adult life has been massive. I experience flashbacks that bring me right back to those moments, as if I am reliving them all over again. These flashbacks can come without warning, triggered by something small, and they leave me feeling overwhelmed and disconnected from the present. It is difficult to explain how exhausting it is to carry memories that you never asked for and never wanted, yet cannot escape.

The trauma has affected my ability to trust people. I often find myself questioning people's intentions, even when they have done nothing wrong. I struggle to feel safe, even in situations where I know logically that I am not in danger. Relationships have been affected too. Letting people get close to me feels risky, and I sometimes pull away without meaning to. The fear of being hurt again sits in the background of my life, influencing decisions and reactions in ways I don't always recognize until afterwards.

Speaking about this now is painful, but it is also part of acknowledging the truth of what I went through. It helps me recognize that the long term effects I live with are not weaknesses — they are the result of surviving something no child should ever have experienced. Putting this into words is a step toward understanding the impact and continuing to move forward.
