I was placed in this home on two separate occasions — first between the ages of two and five, and then again from the age of fourteen to sixteen. I have very little memory of my first time there. It is the second time that has left the deepest and most painful marks on my life.

During my second placement, I was raped by the foster carer's son. I was between seven and eight years old. What happened to me was a serious crime committed against a child, and the impact of that has never fully left me. When I returned to the care home and tried to tell the staff what had happened to me, I was not believed. I was not taken seriously. I was not helped. Instead of being supported through what was an incredibly traumatic experience, I was treated badly for speaking up. The members of staff at the time — Ziggy, Mary, Elaine, and Anna — all knew the boy's father personally, as he was a councillor. I have always felt that this connection had a bearing on how my disclosure was handled, and why those responsible for my care chose to look the other way rather than act.

Since then, the individual who raped me has gone on to rape another person within his own family and is now facing court proceedings. That fact is both vindicating and deeply painful. It confirms what I always knew to be true — that I was telling the truth, and that I was failed by every adult who had a duty to protect me.

The treatment I received from staff following my disclosure was cruel. They spoke to me badly. They stopped my pocket money. They called me a liar. The doors were fitted with locks so that I could not get out. I ran away on multiple occasions, but the police would always bring me back. I was ignored and belittled on a regular basis. I felt profoundly isolated and unwanted, and I was not permitted to form friendships with the other children in the home. What made it even harder to bear was that the other children appeared to be treated reasonably well. I was singled out. I was the one who had spoken up, and I was the one who was made to pay for it. The message I received, loud and clear, was that my safety did not matter, that my words meant nothing, and that the truth I had bravely tried to tell was an inconvenience to the people who were supposed to be caring for me.

The kitchen was locked at night, meaning that if any of us were hungry after a certain hour, we simply had to go without. For a child who was already feeling punished and pushed out, even basic needs felt like they were being used as another means of control.

I was a child who had experienced something horrific, who had found the courage to speak about it, and who was then systematically dismissed, punished, and isolated for doing so. The consequences of that failure have followed me throughout my life, and they are consequences that should never have been mine to carry.

Until the rape happened, I was genuinely happy in this placement. That is something I want to make clear, because it matters. Before everything changed, I had felt settled there. For perhaps the first time in a long time, I had felt something close to a sense of belonging. That is what makes what followed so devastating — because I know what it felt like before, and I know exactly the moment everything was taken from me.

As soon as I told the family that their son had raped me, everything changed. They did not believe me. Instead of being supported, instead of being protected, I was met with denial and hostility. The very people who had made me feel at home became people I was now afraid of.

The abuse that followed was physical. They would lock me in my sister's room, which had a lock on the door. Being confined in that way, in a home where I had once felt safe, was deeply distressing. The room became a place of punishment, a way of silencing me and keeping me out of sight.

The sister isolated me entirely. The whole family stopped speaking to me. I went from feeling like I was part of something to being completely shut out, overnight. That shift — from belonging to invisibility — was one of the most painful things I have ever experienced. I was still living under the same roof as these people, but I had been made to feel as though I did not exist.

I was never given any treats or any of the small kindnesses that had once been a normal part of daily life there. When the other children were taken on trips and outings, I was left behind at home. Every time they left without me, it was a reminder that I was being punished for telling the truth. I was being made to feel that what had happened to me was my fault, and that speaking about it had been the wrong thing to do.

There are few things more damaging to a child than being made to feel worthless by the people who are supposed to care for them. I had been brave enough to speak up after something terrible had been done to me, and in return I was isolated, confined, excluded, and silenced. The happiness I had felt before was real, and it makes the contrast all the more painful to look back on. I deserved to be believed. I deserved to be protected. Instead, I was punished, and that injustice has stayed with me ever since.
