I was taken out of school in 1980 for reasons that were never explained to me and placed in Craig Residential School in Crosshouse, Kilmarnock, Ayrshire, Scotland. From the moment I arrived, I felt frightened, confused, and completely alone. I was given no comfort, no reassurance, and no explanation as to why I had been taken there. Instead, the staff spoke to me harshly from the very beginning. They pushed me around and treated me with no kindness or care. I was only a child, and I felt unsafe from the moment I arrived.

There was no proper education. Every day I was simply made to copy letters from the blackboard. There was no real teaching, no support, and no encouragement. It felt like I had been abandoned in a place where nobody cared about my wellbeing or my future.

The staff bullied us constantly. The bullying came mostly from the adults who were supposed to be looking after us. They would throw us around, shove us, and call us cruel and humiliating names. It created an atmosphere of fear among all the children. Everyone was scared, and nobody felt safe enough to speak up.

I was particularly targeted because I wet the bed as a child. Instead of helping me or showing any understanding, the staff singled me out and humiliated me. They called me "night swimmer" and laughed at me in front of everyone. I was terrified and ashamed. This constant humiliation deeply affected my mental health even at that young age. I became extremely anxious and was constantly on edge, like a bag of nerves.

When I wet the bed, the staff would drag me to cold showers. They would stand at the bottom of the stairs holding up my wet sheets for everyone to see so they could mock me. They would even hang my mattress out of the window so that everyone would know I had wet the bed. It was deeply humiliating and degrading for a child to experience.

I was often kept secluded, and the other children were too frightened to stand up for me or speak out because they were afraid of the staff as well. The staff used force to restrain us. They would sit on top of us, crushing us so we could hardly breathe. They pushed us around and hit us. Sometimes they would strike us across the head with slippers. We were also locked in rooms and isolated from others as punishment.

Food was not always given when we were hungry. I remember being so hungry at times that I ate toothpaste because there was nothing else available. That is how neglected we were.

My brother was also in the school, and I tried to stay close to him because he was the only person who made me feel a little less alone. However, the staff separated us into different dormitories, which was very distressing and frustrating for me.

During the six weeks I was there, family visits were stopped completely. I felt completely cut off from my family and from the outside world. Nobody seemed to care how I was feeling. I felt intimidated, bullied, neglected, and completely powerless.

The impact of what I experienced there has stayed with me throughout my life. The abuse and humiliation I suffered severely affected my mental health. I have struggled to build relationships and trust people. I suffer from depression and ongoing anxiety, and I live with the lasting effects of trauma and PTSD.

What happened to me at Craig Residential School changed my life. The way I was treated as a child left deep emotional scars. I feel that it robbed me of my confidence, my sense of safety, and my ability to live a normal life. In many ways it has left me feeling like only a shell of the person I might have been if I had been treated with care and dignity.
