After this, I was placed at Harmony School, a boarding school, where I remained from around the age of seven until I was twelve years old. I lived away from home during these formative years, entirely dependent on staff for care, discipline, and protection.

Your statement for Care setting 3 continued

From the age of fifteen until I was eighteen, I was placed at the Wellwood Unit in Aberdeen. By the time I left care, my entire childhood and adolescence had been spent within institutional settings.

I experienced physical abuse as a child while living in care. I was subjected to harm by adults who had power and control over me, at a time when I was too young to protect myself or understand why I was being treated this way.

I was physically restrained and tied to my bed on many nights. This caused fear, distress, and a sense of complete helplessness. I was trapped and unable to move, and I felt terrified and alone. The physical restraint was painful and traumatic and left me feeling unsafe and powerless.

I also witnessed physical abuse being carried out against other children. I saw children being hurt and punished in ways that were excessive and frightening. Witnessing other children being abused was deeply distressing and made me constantly fearful that I would be next, or that the abuse would get worse. It created an atmosphere of fear where none of us felt safe.

Seeing other children suffer added to my own trauma. I felt unable to help them and too frightened to speak out. The physical abuse I witnessed, as well as the abuse I experienced myself, had a serious impact on my emotional and psychological wellbeing.

These experiences left lasting effects on me. They contributed to ongoing fear, anxiety, and trauma that I continue to live with today. The physical abuse I endured and witnessed as a child has had a long-term impact on my sense of safety and trust in others.

I was sexually abused by my parents at a very young age. They involved me in sexual behaviour that I did not understand and could not consent to as a child.

My parents told me to masturbate.

This was completely inappropriate and abusive. I was too young to understand what was happening or to know that this behaviour was wrong. I trusted my parents and depended on them for care and safety, and that trust was violated.

I live with Post-Traumatic Stress Disorder (PTSD) and anxiety as a result of the abuse and trauma I experienced during my childhood. These conditions affect me on a daily basis and have a significant impact on my mental and emotional wellbeing.

I also self-harm. I have harmed myself as a way of coping with overwhelming emotional pain and distress.

This behaviour developed as a response to the trauma I experienced and the feelings I have struggled to manage. Self-harm has been a way for me to release or control emotional pain when it becomes too much.

My PTSD causes flashbacks, intrusive thoughts, and ongoing fear.

I struggle with anxiety, which affects my ability to feel safe, relax, or sleep. I often feel on edge and overwhelmed, and simple situations can trigger intense emotional responses.

These mental health difficulties are not a choice. They are the result of what I went through as a child

I was placed into care at six years of age. From that point on, my childhood was spent moving through a series of institutions and children's homes, where I had no stability, safety, or sense of being protected.

When I was six years old, I spent approximately one year in the Sick Children's Hospital in Aberdeen, Ward 7. This was my first experience of being separated from my family and placed under the control of adults and systems I did not understand.
