The mental abuse I experienced in this placement was severe, and whilst the physical punishment was real and painful, it was the psychological cruelty that affected me most deeply. The nuns would cane us, but it was the mental torture that left the more lasting wounds. That is saying something, because the physical pain was far from insignificant.

One of the ways they controlled us was through the threat of keeping us in at weekends and stopping us from going home. For many young people, the prospect of seeing family at the weekend is the one thing that keeps them going through the week. Using that as leverage was a particularly cruel form of manipulation, because they knew exactly how much it meant to us.

On my thirteenth birthday, they carried out that threat against me. I was stopped from going home on my own birthday. I did not see my mother for a full week after that. I was permitted to speak to her briefly on the phone, but that was all. My mother was in poor health, and she lived two train journeys away, which made the distance between us feel even greater. To be kept from her on my birthday, at thirteen years old, was heartbreaking. It is the kind of thing that stays with you.

The way staff spoke to us was awful. We were belittled, ignored, and made to feel small on a daily basis. If we were late for class, we were caned. There was no compassion, no understanding, no effort to find out why a young person might be struggling. The response to any perceived wrongdoing was punishment, and the punishment was physical.

Our privacy was nonexistent. Staff would watch us whilst we showered. We were monitored constantly, and that persistent lack of privacy created a feeling of vulnerability and exposure that never went away. Being watched in moments that should be entirely private is a violation, regardless of who is doing it or what justification is offered.

Because I was sleepwalking, I was locked in my room at night. I understood on some level that there may have been a reason behind it, but what stayed with me was the fear. I was terrified about what would happen if there was a fire. Being locked in a room with no way out, and lying awake worrying about whether I would be able to escape if something went wrong, added a layer of anxiety to my nights that I should never have had to carry.

There was a French teacher called Mrs Reed who was particularly difficult. Her behaviour towards us added to the overall atmosphere of harshness and disdain that characterised that place.

I want to make clear that I had only entered care in the first place because I had not been attending school. My mother fought to have me placed in an open unit, which would have been far more appropriate for my circumstances. Social workers were of no help. Her efforts were ignored, and instead I found myself in an environment where I was caned, belittled, monitored in private moments, locked in at night, and denied the chance to be with my mother on my own birthday. The response to my situation was disproportionate, the treatment I received was damaging, and the people who were supposed to advocate for me failed to do so.
