I was taken to Glasgow Sheriff Court on Ingram Street in Glasgow. At the time, the judge was Lord Bell. There was a mistake with my date of birth at court, and as a result, I was sent to HMP Glenochil even though I was only 15 years old. I tried multiple times to tell them that I shouldn't be going there, but they sent me anyway.

When I first arrived at Glenochil, I remember sitting in the reception area. The guard gave me my uniform, along with two others. We were taken through two sets of doors and into the wings. I was shown to my cell. It was very cold and dark, and I was scared.

The staff were brutal with me, especially because I was the youngest and a new arrival. I received several beatings from both staff and inmates. There were two staff members in particular, Mr. Ambrose and Mr. McAllister—the latter was the senior officer and a bully. I also struggled with bedwetting. One morning, Mr. McAllister came into my cell, noticed the wet bed, and made me carry the mattress through the wing while everyone stood outside their cells. I had to drag it in front of everyone so they could see what had happened. I was laughed at and called names like “pishy.”

The staff would sometimes enter our rooms during the night. We would be down by the pipes talking to other inmates, and they would drag us out by the ankles, kick us, and slap us. I often lay awake crying for the rest of the night. I never once had a proper night's sleep there because I was constantly afraid that the staff would come in and attack me for no reason. Some staff members would come in smelling of alcohol, and a few times I saw staff who were clearly under the influence. We were made to get up at 6 a.m. every morning to go for a 1,500-meter run. We had to complete it in just over five minutes, no matter the weather—rain, snow, ice, or freezing cold. After the run, we would have breakfast and then be locked back in our cells until 10:30 a.m. We were forced to stand naked in line for showers and had to shave every day before being inspected by staff. We were only allowed a shower every few days, even though I regularly went to the gym. We were permitted to write to our families, but the letters were checked by staff. If we mentioned the way we were being treated or anything they didn't like, they would tear the letter up and make us rewrite it, or they would send us back to our cells without letting us write at all.

After three months, I was allowed to go home. However, the trauma and abuse I experienced there made life outside much harder.

Your statement for Care setting 2 continued

I struggled to trust people and soon found myself in YOI Polmont. When I arrived there, my cell only had a mattress on the floor. Breakfast was served at 9 a.m., and after that, the door was locked. We were never allowed to exercise. There was a staff member named Joe Alison, known as "Crazy Joe." He would come into my cell, take my mattress away, strip me naked, and leave me like that for days. He would spit in my food so I wouldn't eat, and his sidekick, Mr. Brown, was just as bad. Whenever Celtic were playing, Mr. Brown would come in smelling of drink. Depending on the result of the game, he would either be in a good mood or take his anger out on us. I was often kicked and beaten for no reason. I recall I was placed in segregation, locked alone in a dark room, stripped naked, and left there for several days.

One day, they opened the door, threw me to the ground, zip-tied my hands, and put me in the back of a van. I was taken back to Glenochil. When I returned there at 17, I was again beaten by staff. I managed to get a job in the engineering department, but one day some of the boys used a sanding machine to sharpen pieces of metal into knife like objects and attacked another inmate later that shift. I was taken to the hospital ward, and a few hours later the whole wing was closed for a police investigation. I was too scared to say anything. Today, I still struggle with my mental health. My experiences in prison left me with deep trauma, and I have battled addiction for many years. I have several health issues but I'm trying to turn my life around. I'm hoping to start college soon, and I'm proud to say I have now been six years free from addiction

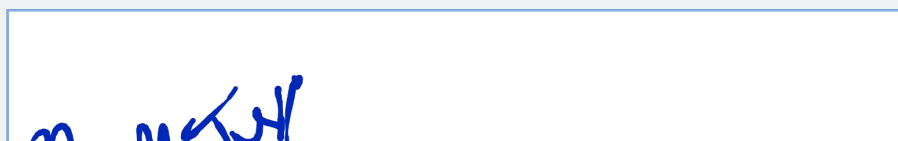
