I was placed in this home alongside my brother, and for a time, at least having him there gave me something to hold onto. But that was taken from us. The home deliberately took my brother away on a trip, and used that as an opportunity to split us up permanently. After that, we were never placed together again. I did not see him properly until I was sixteen years old, when we were both living in a homeless unit. The fact that we were separated in that way, deliberately and without any regard for what it meant to us, is something I have never been able to fully make peace with.

My brother's life was deeply affected by everything we both went through during that time. He went on to struggle with drug addiction, and he has since passed away. I believe, with everything I have in me, that the way we were both treated during our time in care played a significant part in what happened to him. That loss is something I carry every day.

During my time there, one male member of staff behaved towards me in a way that I now recognise as completely inappropriate and abusive. He would cuddle up to me and rub himself against me. At the time, I did not fully understand what was happening. I thought it was normal, because I had nothing to compare it to and no one to tell me otherwise. That in itself is deeply troubling — that a child could be made to feel that kind of behaviour was acceptable.

I was also subjected to physical abuse by multiple members of staff. I was hit all over my body. I was put in rooms alone. I was restrained — staff would force my arm up my back and put me in a headlock. One female member of staff would poke me repeatedly, and I would be left with bruises. The bruises were always on my body, never on my face. I believe that was intentional — so that the marks would not be visible or easily noticed by anyone from the outside.

The physical pain was real, but so was the psychological damage. Being hurt by the very people who were supposed to be caring for you leaves a mark that goes far beyond the physical. I felt powerless, frightened, and completely without protection.

Being separated from my brother only made everything worse. He was my family, the one familiar thing I had in an environment that felt hostile and unsafe. Losing that closeness, at such a young age and in such a deliberate way, compounded everything I was already experiencing. By the time we were reunited at sixteen, in a homeless unit, so much had already happened to both of us. So much had already been lost.

I share all of this not for sympathy, but because it is the truth of what happened to me, and to my brother. He is no longer here to speak for himself, and I feel the weight of that deeply.

Your statement for Care setting 2 continued

In this placement, the windows in my room were boarded up. That alone tells you something about the environment I was living in — it felt less like a place of care and more like a place of containment.

At some point during my time there, all of my clothes were taken from me. All I was left with was a single pink onesie, and that was all I had to wear for around three weeks. They would not wash it, because I had nothing else to change into. The reason my clothes were removed was because they believed I would run away. When I was in my pyjamas, they felt they had more control over me. It was degrading. Being stripped of something as basic as clean clothing was yet another way of making me feel worthless and powerless.

Despite everything they did to try to stop me, I did still run away — not out of recklessness, but because I needed to see my brother. He was the one person I had, and being kept from him was unbearable. However, my brother would always send me back. As painful as that was, I understand now that he was trying to protect me in the only way he could.

During my time there, I was also hit in the eye by another child using a pool cue. I was left with a severe black eye. Whether it was intentional or not, the fact remains that it happened in an environment where I already felt unsafe, and it only added to that.

The restraints used on me in this placement were particularly traumatic. On multiple occasions, two members of staff at a time would restrain me. It was rough, it was frightening, and it felt completely excessive. After being restrained, I would be dragged back to my room, and the windows would be boarded up again. That cycle — restraint, isolation, confinement — repeated itself, and the impact of that on me was significant.

There were some small allowances. We were permitted to work up to four times a day, provided our parents had given their consent. We were also made to do all of the cleaning in the home, which again felt like we were there to serve the needs of the place rather than be cared for within it.

I want to be fair and acknowledge that some of the staff were genuinely kind. Not everyone who worked there was cruel, and I recognised that even at the time. But the actions of those who were awful were severe enough to leave a lasting mark, and the overall environment was one that caused real harm.

The good did not undo the bad, and for a young person who simply needed to feel safe and supported, the experience left wounds that have taken a very long time to begin to process. The rooms felt like I was in a prison cell.
