I was only in this home for a few weeks, but what I witnessed and experienced during that short time has stayed with me for the rest of my life. I was there alongside my brother, and it is the way he was treated in particular that has never left my mind.

My brother struggled with bed wetting, as many young children do. Rather than being met with any understanding or compassion, he was publicly humiliated for it. The staff would make him hang his wet bed sheets out of the window for everyone to see. There was no privacy, no kindness, and no consideration for how a child would feel being shamed in that way. As though that were not enough, he was also made to stand there whilst he was still cold and wet. Watching my brother be treated like that was deeply distressing, and the shame that was deliberately inflicted on him is something that has always stayed with me. He did not deserve that. No child does.

I was only three years old at the time, and the physical demands placed upon us were completely unsuitable for children of our age. We were made to walk very long distances, and the terrain was not even a proper road — it was rocky and uneven, which made it even harder for me to manage at such a young age. There was no consideration given to how small we were or what we were capable of.

One memory that stands out clearly is coming down the large staircase and watching the matron hand out pocket money. My brother and I never received any. We would stand there and watch the other children receive theirs, and the feeling of being left out and overlooked was one I felt very deeply, even at that young age. We were also never given sweets, whilst others around us were. These may seem like small things, but to a young child they represented something much larger — the feeling of being invisible, of not mattering, of being treated as less than those around us.

We were given no choice over what we ate, and I remember disliking the food that was put in front of us. Having no say in even the most basic aspects of daily life added to the sense of powerlessness that defined our time there.

I also remember a girl whose birthday came whilst we were there. She was given a doll in a box, but there was no party, no celebration, and no sense that her day was in any way special. The doll itself was not something a child would have been happy to receive. That image has stayed with me as a reflection of the overall atmosphere in that place — joyless, cold, and entirely lacking in warmth or genuine care for the children who lived there.

Although my time in this home was relatively brief, the impact of what I saw and experienced has been anything but. The public shaming of my brother in particular is something that has always stuck in my mind. We were young, vulnerable children who needed care and kindness, and instead we were met with humiliation and indifference. That is not something a person simply forgets, no matter how much time passes.

The effects of what I experienced have followed me into every corner of my adult life. I have struggled significantly with depression, and I am on medication as a result. My personal relationships have also been profoundly affected. I have been married five times, and I believe this is deeply connected to what I went through as a child. The treatment I received at such a young age shaped the way I respond to people, particularly when I feel I am being treated badly. As soon as someone treats me poorly, something inside me compels me to leave. I cannot tolerate being mistreated, and whilst I understand why that is — given what I experienced — it has made sustaining long-term relationships very difficult. I do not say this with shame. I say it because it is the truth of how the failures of those who were meant to care for me have rippled outward and touched every significant relationship in my life. The consequences of those few weeks have been far reaching and long lasting, and I feel it is important that this is fully understood and acknowledged.
