My first memories of being in care began when I was sent to an assessment centre in Dunfermline. From the moment my brother and I arrived, there were already other children there who would pick on us. I was very young at the time, and this was my first experience of care.

While I was there, I experienced sexual abuse that has stayed with me for my entire life. I will never forget the night a minister climbed through the large bay window during the night and sexually abused me. He touched me inappropriately and did things to me that no child should ever experience. I screamed because I was terrified and did not want this to happen to my younger brother. I was panicked, traumatised, and completely helpless. When I screamed, the minister jumped back out of the window and fled.

Staff came into the room after hearing me scream. Instead of helping me or protecting me, they laughed at me, turned the light off, and locked the door, leaving me alone and frightened. The staff were aware of what had happened and ignored it completely.

Two days later, every other child in that care home was removed, except for me and my brother. We were left there on our own with the staff for approximately one to two weeks. This deeply affected me, as it was my very first experience in care. I was scared, confused, and constantly worried about what was going to happen to us next.

After this, we were placed back home for a few months. During this time, my family noticed that I had changed and was no longer the same child after what had happened. Shortly after this, my mother passed away, and I was placed back into the care system.

## Your statement for Care setting 2 continued

I was then placed in Latchgrove in Glasgow, which was the worst place of all. Every single night, I was forced to fight. These fights left me with bruises, cuts, and broken bones. This was done purely for entertainment. I was regularly made to fight Frankie Docherty every night in exchange for a cigarette. I was terrified for my life. Latchgrove felt like a prison. I was rarely allowed out of my room. Staff controlled how I spoke and behaved. I lived in fear every single night, expecting to be punched, kicked, or seriously injured. I was again punished with belts and was regularly locked in a cell for days at a time, often with very little food or water. My time in care stripped me of my dignity and my sense of self. I was abused sexually, physically, and mentally across multiple placements. These experiences have impacted every part of my life. I now suffer from PTSD, anxiety, and severe stress. I do not trust people. I cannot sleep properly at night. I have had to live with these memories my entire life, and no one can truly understand what I have been through. I am also living with a terminal illness, which has added to my suffering. I have never been pain-free, either physically or mentally. My mental health has been severely damaged, and I struggle daily. I hate waking up and being forced to relive these memories over and over again.




