Teachers used to come in while I was bathing, and it always made me feel extremely uncomfortable. I remember feeling exposed and anxious every time they walked in. They would make me see how long I could hold my breath under the water, and even though it seemed like a “test” to them, it made me feel scared and pressured. I didn’t feel safe with them around me in such a vulnerable situation. The whole experience left me feeling uneasy and confused, and it took away any sense of privacy I should have had.

They also used to hit me if they said I was “misbehaving.” It wasn’t just a one off incident — it happened more than once, and over time it became something I almost expected. There were moments when they would restrain me, but it wasn’t just restraining. They would hit me while doing it, and the force and aggression they used made it clear that it was more about punishment than control. I remember feeling terrified, not knowing when it would happen again or what would set them off.

There were times when they hit me with belts as well. Those moments were awful and left me feeling completely powerless. The physical pain was one thing, but the emotional impact — the fear, the humiliation, the sense of being trapped — was even harder to cope with. It created an environment where I was constantly on edge, always bracing myself for the next incident.

There was more that happened, but some of it is difficult to remember clearly. The fear and stress of that time have made certain memories blurry, but the feelings have stayed with me. What I do remember is the constant sense of dread, the lack of safety, and the way I felt like I had no control over what was happening to me.

I was also a witness to other children being hit and beaten. Seeing it happen to others made everything even more frightening. It showed me that no one was safe and that the abuse wasn’t isolated — it was part of the environment. Watching other children go through the same things left a deep emotional mark on me, because I knew exactly how it felt and I couldn’t help them.

All of these experiences have had a lasting effect on me. The fear, the lack of safety, and the constant abuse shaped the way I saw myself and the world. Even now, the memories affect me mentally and emotionally. What happened during that time has stayed with me, and it continues to impact me to this day.

Michael McNagal used to make sunbeds, and he would strip naked and turn around in front of me. It made me feel extremely uncomfortable and confused. I didn't understand why an adult would behave like that, but I remember feeling trapped in the situation, unable to say anything or protect myself. He also used to make us attend what he called "sex education classes," but we had to go in one at a time. When it was my turn, he would sexually abuse me. He touched me in ways that were completely inappropriate and deeply distressing. I felt scared, ashamed, and powerless, and I didn't know how to make it stop. Those experiences have stayed with me for years.

There were quite a few times when they would "restrain" me, but it wasn't just restraining. They would hit me while doing it. I was hit on more than one occasion, and it became something I almost expected because it happened so often. The physical pain was one thing, but the fear and humiliation that came with it were even worse. They would also hit me with belts, and those moments were awful. I remember feeling completely helpless, like there was no escape and no one who would listen or believe me.

I was also a witness to other children being hit and beaten. It wasn't just happening to me — it was happening to many of us. Seeing other children go through the same abuse made the environment even more frightening. It created a constant sense of dread, knowing that at any moment it could be me or someone else being hurt again. Watching others suffer left a deep emotional mark on me, because I knew exactly how they felt and I couldn't do anything to help them.

All of these experiences have had a lasting impact on me. The fear, the confusion, and the constant abuse shaped the way I saw myself and the world around me. Even now, the memories affect me mentally and emotionally. What happened wasn't just a series of isolated incidents — it was a pattern of abuse that has stayed with me throughout my life.
