During my time in this home, I experienced something that no child should ever have to endure. I was around 13 years old — a vulnerable young girl who should have been protected — when a fellow resident named Brian Ferrier began persistently trying to get me to show my breasts. He hounded me constantly, and the harassment never seemed to stop. It was relentless, uncomfortable, and deeply frightening for a child of my age. I felt exposed and unsafe in a place that was supposed to be my home, and the effect that had on me was significant.

What made it even harder to bear was the response — or rather, the lack of response — from the staff. The very people who were responsible for my safety and wellbeing largely failed to take meaningful action to stop what was happening to me. I was a 13 year old girl being repeatedly harassed, and I was not adequately protected. That failure hurt almost as much as the harassment itself, because it sent a very clear message to me — that what was happening to me was not important enough to be dealt with, and that I was not important enough to be properly safeguarded. As a child, that feeling of being unprotected and unseen by the adults around you leaves a mark that does not simply fade with time.

The combination of the harassment I was subjected to by Brian Ferrier and the broader mistreatment I was experiencing within the home became too much for me to cope with. I felt trapped, frightened, and completely without support. As a result, I ran away from the home on a number of occasions. Looking back, running away was not a choice I made lightly — it was an act of desperation from a child who felt she had no other option. I did not run away because I was difficult or troublesome. I ran away because I was not safe, and because nobody in that home was doing enough to make me feel otherwise.

The impact of what I experienced there has stayed with me long beyond those years, and it forms a significant part of the wider picture of harm that was done to me during my time in care.

I spent a few months in this placement, and it is something that has never truly left me. No matter how hard I have tried to push it to the back of my mind over the years, the memories — the ones I can recall — still carry a pain that is difficult to put into words. It was, without question, one of the worst and most damaging experiences of my entire life.

From the very first moment I arrived, I was made to feel completely worthless. There had been no preparation made for me, no thought given to the fact that I was a child who needed a bed, a safe space, somewhere to feel human. Nobody knew I was coming, and so I was placed on a mattress on the floor in the corridor. Not in a room. Not in a bed. On the floor, in a corridor, like I was nothing. That memory has stayed with me, because in that moment I understood exactly how little I mattered to the people who were supposed to be caring for me.

The control they exerted over even the smallest things, like food, felt cruel in a way I still struggle to fully describe. I was given no choice, no voice, and no consideration. I was forced to eat mushroom soup regardless of how much I struggled with it, and the effect of that has never left me — to this day, I cannot eat it. The taste, the memory, they are bound together in a way I cannot separate. I also had no experience of brown bread before arriving there. It was completely unknown to me, yet I was forced to eat it without any kindness or understanding. When I refused, I was hit in the face with a rolled up newspaper. I was a child. I was frightened and confused, and instead of being met with patience, I was met with humiliation and pain. Even now, I do not eat brown bread, and I know deep down that is because of what happened in that place.

I was also forced to have cold showers that were absolutely freezing. There was nothing accidental about it — it felt deliberate, another way of reminding me that my comfort, my dignity, and my wellbeing simply did not matter. My sister was there with me through this, and in many ways the only way we both survived it was by trying to shut it out entirely. We made an unspoken agreement with ourselves to blank out the past, to bury it, to keep moving forward without looking back. For a long time, that felt like the only option we had. But burying pain does not make it disappear — it simply finds other ways to surface. My own son has watched me struggle for years. He has seen me shut down when the past comes too close, seen me unable to remember things that should be there, noticed the gaps that the trauma has left behind. It is because of him, and his quiet, persistent encouragement, that I have been urged to seek therapy and finally begin to talk about what I went through.

The fact that my child has had to witness the lasting damage of my childhood, and has had to be the one to gently push me towards healing, is something that moves me deeply. It is a reminder that the harm done to me in that placement did not just affect me in those months — it has followed me through every year of my life since, and it is only now that I am beginning to face it.
