I was first placed into care at 11 years old. I was taken to Cardross Assessment Centre, where I stayed for approximately three weeks. From the moment I arrived, my anxiety was overwhelming. I remember feeling immediate fear. The environment was chaotic — children were running around, fighting, and behaving in a way that felt completely out of control. I felt unsafe from the very first night.

On my first night, staff members were speaking to me in a nasty and aggressive manner. They were shouting at me and at other children. Instead of feeling protected, I felt intimidated and frightened by the very people who were supposed to care for me. I was locked in my room frequently. Although isolation is frightening for a child, I often felt safer locked in my room than being around the other children, because they would beat me and kick me. I was physically assaulted repeatedly.

The staff allowed this to happen. They did nothing to protect me. At times, they would laugh and torment me. I felt that they would deliberately set the other children on me to scare me. Cardross housed both boys and girls. The boys would laugh at me, call me names, and humiliate me. Older girls would hit me and pull my skirt up to expose me and make a fool of me. It was degrading and deeply embarrassing. I felt ashamed and powerless. The staff stood by and did nothing.

Those three weeks felt endless. I was bullied, terrorised, physically assaulted, and emotionally abused daily. My mental health deteriorated rapidly. I felt constantly anxious, on edge, and unable to relax. I was only 11 years old and already living in constant fear.

## Your statement for Care setting 2 continued

After around three weeks, I was moved to Snowdon Children's Home, where I remained until I turned 16.

When I arrived at Snowdon, the abuse continued immediately. The staff were very aggressive. They would scream and shout in our faces and push us down corridors. We were frequently locked away. Food was provided, but it was often cold and stale. Many nights, myself and other children went to bed hungry. We were neglected emotionally and physically.

It was at Snowdon that the sexual abuse began.

My mum stopped coming to visit me on weekends. I felt completely abandoned and alone. During this time, we went on a camping trip organised by the home. My key worker was Jock (I cannot remember his second name). On the first camping trip, when everyone was in their tents asleep, Jock kissed me. He then took me to the shower room and sexually assaulted me. I was terrified and confused. I did not understand what was happening. I felt frozen with fear.

After that first assault, the abuse became regular. It happened repeatedly and whenever he had the opportunity. I was too scared to tell anyone. He would threaten me and use other children to intimidate me. He would get them to hit me. I felt completely trapped. I had no visitors. For 28 weeks, I had no home leave and no one came to see me. I was isolated and vulnerable.

When the other girls were away on weekend visits, Jock would come into my room and sexually abuse me. It happened as often as he could manage. On one occasion, he took me shopping and then took me to his house. He took me upstairs and had sex with me. He then took me back to Snowdon as if nothing had happened. I was a child. I did not consent. I was groomed, manipulated, threatened, and repeatedly sexually abused by a man who was supposed to protect me.

I cannot clearly remember when the abuse stopped, but I remember that Jock later moved to Canada with his wife and children.

Throughout my time at Snowdon, staff failed to protect me. Anything could happen and there were no consequences. I was also physically attacked by other children and constantly victimised. Jock ensured I was targeted. I was beaten, mistreated, emotionally abused, neglected, and sexually abused throughout my time in care until I turned 16 and was forced to leave and survive on my own.

The impact of this abuse has been lifelong and devastating.

My whole body changed. My personality changed. I became withdrawn, fearful, and unable to trust anyone. I suffer severely with PTSD and chronic anxiety. I have frequent sleepless nights due to nightmares and flashbacks. I relive the abuse in my mind. I struggle to speak about what happened. I avoid situations that trigger memories. I am constantly on edge, hyperaware, and fearful.

I struggle deeply with trust and relationships. I feel shame and humiliation about what was done to me. I experience panic attacks and overwhelming anxiety. My mental health has been severely damaged as a direct result of the physical, emotional, and sexual abuse I suffered in care.

This trauma has affected every part of my life — my relationships, my self-worth, my ability to feel safe, and my ability to function normally. I feel that my childhood was stolen from me. The people who were responsible for protecting me abused and failed me in the worst possible ways.

The abuse I suffered at Cardross Assessment Centre and Snowdon Children's Home has ruined my life and continues to affect me every single day.
